This month we need to finalize the table manning schedule and collect the rest of the items for the charity sale. In the past some of us and the club, in general, has become a point where people have dropped off old stamp collections that people do not know what to do with. Question, what can we do about this (*other than refuse the*) "donation" of a collection that has been improperly stored?

In general, the items we collect are all susceptible to mold if stored improperly. Our enemies are mold which is a growth caused by fungi that appears gray-black and fuzzy in texture. Mildew is a another type of mold that emits a strong musty smell. Mold and mildew destroy stamps and albums because they stain and eat the paper/adhesive. These molds will begin to grow when humidity in the atmosphere is above 55% and in warm, damp, dark, poorly ventilated areas like attics, garages and basements. These places are the worst place for collections that people inherit because they not only invite mold and mildew, but also by bugs and rodents that feed on and nest in collection. When the time comes to clean out these places these collections are discovered to bear mold and the owner will try and sell of them at a garage sale, to a stamp dealer, or in desperation donate them to us.



Besides the degradation of value of the collection, mold and mildew can trigger allergies and asthma attacks, making it unhealthy for us if we are not careful.

If there is something that appears to be of value, we can minimize further growth of mold and also prevent the stamps from growing mold that are inexpensive and will help us to preserve them. The easiest ways to remove a small amount of mildew from the object are by a computer keyboard (with brush) vacuum or a dry cloth. With the vacuum method make
