## MESSAGE FROM THE POSTMASTER GENERAL

## Delivery Bar Code Sorter Label Ordering Procedures

Two indefinite delivery, indefinite quantity contracts have been awarded for delivery bar code sorter (DBCS) labels. Use these labels only with Martin Marietta and ElectroCom DBCSs. They have been tested and approved by the Postal Service Engineering Center. Labels from

other suppliers have not been tested and often fail to perform properly in mail-sorting operations.

Intermec Media Products is the mandatory source of supply for rolled labels. Barcodes West, Inc., is the mandatory source of supply for fan-folded labels.

### General Ordering Information

Follow the procedures below for ordering DBCS labels:

- Ordering offices should use VISA credit cards to place orders directly with the appropriate vendor.
- Use the order forms in *Material Logistics Bulletins* MLB-CO-95-004 and MLB-CO-95-005 to place orders.
- Orders will be sent within 2 weeks after the date the order is received by the vendor.

- Orders for less than 32 boxes are shipped via First-Class permit mail directly to the requiring facility. Orders for 32 boxes or more are shipped via motor freight carrier.
- Provide the vendor a government bill of lading for large orders.
- Order full boxes only.

### Availability of Handbook AS-701, *Material Management*

The revised Handbook AS-701, *Material Management*, will be available by the end of April from the Topeka and Somerville material distribution centers (MDCs).

This is a complete revision of the November 1991 edition. It is organized by major retail material management processes: shipping and receiving, government bill of lading, storage space management, stockroom management, asset accountability, and asset recovery—redistribution, recycling, and disposal. This handbook supersedes both the previous Handbook AS-701 and Handbook AS-701A, *Material Management for Small Offices*.

An overview of the handbook will be offered in a satellite broadcast during May 1995. The timing of this broadcast will be published in the next *Postal Bulletin*. Material management specialists, material accountability officers, stockroom personnel, and all others having duties that re-

late to the receipt, issue, storage, and transport of material in support of postal operations should view this broadcast.

Automatic distribution of the handbook will be as follows:

- Maintenance stockrooms.
- Purchasing and materials service centers.
- District material management specialists.
- Post offices CAG A–G.

All other offices should order copies of the handbook from their servicing MDC. In the near future the handbook will be accessible through the purchasing and materials local area network (LAN).

## Phase Out of Pitney Bowes Model 2200 Series Postage Meter

The Pitney Bowes Model 2200 Series (R Line) postage meters were decertified for commercial use effective January 4, 1995. As a result, Pitney Bowes will no longer provide any support for these meters, including those installed at post offices. Orders for town circles or meter dies will not be honored. The termination of Pitney Bowes' support is effective immediately.

Post offices are permitted to use these meters until they malfunction and need repair or until they are no longer needed. When either situation occurs, post offices must send these meters to Pitney Bowes for destruction. Meters

**Business Reply Mail Format Element**

Effective immediately, *Domestic Mail Manual* (DMM) S922.6.7a is corrected to show that the business reply mail (BRM) format element "FIRST-CLASS MAIL PERMIT NO." requires a hyphen between "FIRST" and "CLASS" as illustrated in DMM Exhibits S922.4.4, S922.4.10, and S922.6.10. (BRM format standards for federal agencies and the Postal Service appear in DMM E060.)

First-Class Mail is a Postal Service trademark and must be written with the first letter of each word capitalized (or the words written in all capital letters) and a hyphen inserted between the first and second words (see DMM G013). The hyphen was inadvertently omitted in previous DMM issues, and this correction will appear in DMM Issue 49.

**S922.6.7 Window Envelopes**

Other standards apply specifically to BRM prepared in a window or open-panel envelope:

- a. The endorsement "NO POSTAGE NECESSARY IF MAILED IN THE UNITED STATES," horizontal bars, FIM, and the legend "BUSINESS REPLY MAIL" must be printed on the address side of the envelope. Other required elements include "FIRST-CLASS MAIL PERMIT NO.," city, state, and "POSTAGE WILL BE PAID BY THE ADDRESSEE." The permit holder's name and complete delivery address must appear on the enclosure in the window or be printed on the envelope.

grated retail terminal (IRT) to determine whether an APO/FPO ZIP Code is active and what conditions of mailing apply. For Express Mail Military Service (EMMS) availability, refer to Handbook PO-514, *Express Mail Military Service*, and the local EMMS directory.

Note: Mail order catalogs are prohibited as SAM or PAL mail.

**A.** Securities, currency, or precious metals in their raw, unmanufactured state are prohibited. Official shipments are exempt from this restriction.

**B.** Form 2966-A is required. Prepaid mail from a contractor addressed to a military organization for official use need not bear a customs declaration, but must be endorsed "Contents for Official Use—Exempt from Customs Requirement." Official mail from government agencies does not require a customs declaration or an exemption endorsement.

**B1.** Form 2966-B is required. Articles are liable for customs duty and/or purchase tax unless they are bona fide gifts intended for use by military personnel or their dependents. When the contents of a parcel meet these requirements, the mailer must endorse the customs form, "Certified to be a bona fide gift, personal effects, or items for personal use of military personnel and dependents," under the heading, Description of Contents.

**B2.** Form 2966-A is required except on official mail, which does not require customs declaration or exemption endorsement. The AAFES will furnish a computer listing of all items mailed from its activities to Philippine APOs. Other mail order companies must either use Form 2966-A on each item or provide computer lists. Computer listings must include a description of the items, the dollar values of the items, and complete address including the PSC box number and APO of the addressee, the date of mailing, the insurance registry number, if applicable, and the serial number of any item over \$25 in value and any electrical item with a plug over \$15 in value.

**B3.** Form 2966-A is required for mailing between MPOs. Prepaid mail from contractors addressed to a military organization for official use need not bear a customs declaration, but must be endorsed "Contents for Official Use—Exempt from Customs Requirement." Official mail from government agencies does not require a customs declaration or exemption endorsement.

**C.** Cigarettes and other tobacco products are prohibited.

**C1.** Obscene articles, prints, paintings, cards, films, videotape, etc., and horror comics and matrices are prohibited.

**D.** Coffee is prohibited.

**E1.** Medicines or vaccines not conforming to French laws are prohibited.

**E2.** Any matter containing religious materials contrary to Islamic faith or depicting nude or seminude persons, pornographic or sexual items, or nonauthorized political materials is prohibited.

**E3.** Radio transceivers or cordless telephones are prohibited.

**F.** Firearms of any type are prohibited in all classes of mail. See definitions of firearms in DMM C022.1.1. This restriction does not apply to firearms mailed to or by official U.S. government agencies.

**F1.** Privately owned weapons addressed to an individual are prohibited in any class of mail.

**F2.** Importation of firearms is restricted to one shotgun and one single shot .22 caliber rifle per individual.

**G.** Only First-Class letters, second- and third-class mail are authorized.

**H.** Meats, including preserved meats, whether hermetically sealed or not, are prohibited.

**H1.** Pork or pork by-products are prohibited.

**I.** Mail of all classes must fit in a mail sack. Mail may not exceed the following dimensions:

Length

- 42" . . . . . 72" length and girth combined
- over 42" to 44" . . . . . 24" girth
- over 44" to 46" . . . . . 20" girth
- over 46" to 48" . . . . . 16" girth
- Maximum length 48"

This restriction does not apply to registered mail and official government mail marked MOM.

**K.** Mail that includes in the address the words, "Dependent Mail Section," may consist only of letter mail, newspapers, magazines and books. No parcel of any class containing any other matter may be mailed to the Dependent Mail section. This restriction does not apply if the address does not include the words "Dependent Mail Section."

**L.** All official mail is prohibited.

**M.** Fruits, animals, and living plants are prohibited.

**N.** Registered mail is prohibited.

**O.** Personal mail addressed to vessels using this number is limited to unregistered First-Class Mail and certified mail. Other classes of mail are prohibited

**P.** APO is used for the receipt and dispatch of official mail only.

**Q.** Mail may not exceed 66 pounds, and size is limited to 42 inches maximum length and 72 inches maximum length and girth combined.

**R.** All alcoholic beverages, including those mailable under DMM part C021, are prohibited.

**R1.** Materials used in the production of alcoholic beverages (i.e., distilling material, hops, malts, yeast, etc.) are prohibited.

**T.** Mailings of case lots of food and supplemental household shipments must be approved by the sender's parent agency prior to mailing.

**U.** Parcels must weigh less than 16 ounces when addressed to Box R. This restriction does not apply to mail endorsed "Free Matter for the Blind or Handicapped."

**U1.** Mail is limited to First-Class Mail weighing 12 ounces or less when addressed to Box R. This restriction does not apply to mail endorsed "Free Matter for the Blind or Handicapped." Videotapes are prohibited when addressed to Box R, regardless of weight.

**U2.** Mail is limited to First-Class letters only when addressed to Box R.

**U3.** Mail is limited to First-Class correspondence (including voice and video cassettes), newspapers, magazines, photographs, not exceeding 16 ounces, when addressed to Box R.

**W.** Meat products, such as dried beef, salami, and sausage, may be mailed, provided they remain in their original, hermetically sealed packages and bear USDA certification. Other meats, bones, skin, hair, feathers, horns or hoofs of hoofed animals, wool samples, tobacco leaves, including chewing and pipe tobacco, snuff, cigars, and cigarettes, or obscene material, including obscene drawings, photographs, films, and carvings, are prohibited. Exception: 200 grams of tobacco per parcel are permitted duty free.

**X.** Personal mail is limited to First-Class Mail (to include audio cassettes and voice tapes) weighing 11 ounces or less. This limitation does not apply to official mail.

**Y.** Mail is limited to First-Class and Priority Mail only. All second-class, third-class, and fourth-class mail (including SAM and PAL) are not authorized. This restriction also applies to official mail.

## FINANCE

### Migratory Bird Stamp Disposition

Post offices, stations and branches, and standard field accounting procedures offices must submit unsold migratory bird stamps for destruction during postal quarter (PQ) III according to the procedures outlined below. Stamp distribution network offices (SDOs) that shipped bird stock to the stamp distribution network (SDN) prior to publication of this *Postal Bulletin* notice should disregard the procedures below.

#### Stamp Distribution Offices

1. Postmasters must complete these tasks:
  - Submit for destruction unsold migratory bird stamps during PQ III as instructed in Handbook F-1, *Post Office Accounting Procedures*, section 466, "Disposition of Nonsalable Stock."
  - Verify accounting period (A/P) 9 or PQ III statement of account to ensure that the entry to AIC 511, Bird Stamps Destroyed, equals the amount in AIC 806, Ending Inventory—Bird Stamps, on the previous statement of account.
  - Report any problems or discrepancies for resolution to the district accounting office.
2. District customer service and sales offices must complete these tasks:
  - Establish a destruction schedule to submit all unsold bird stamps to the stamp stock destruction committee no later than A/P 8, ending April 28, 1995.
  - Return properly certified Forms 3238, *Stamps and Stamped Paper Destruction Certificate*, (see section 450) to post offices for inclusion with the statement of account for PQ III or A/P 9, ending May 26, 1995.
3. Main stock IRT offices must complete these tasks:
  - Return all bird stamps to the main stock using a valid item number for bird stamps (offices with UNISYS integrated retail terminals (IRTs) must use item numbers between 322–325).
  - Do not enter these bird stamps as redeemed stock.
  - Print Form 3958 and verify that the total in the bird stamp portion of Form 3958 equals both of the following:
    - a. The value of bird stamps on hand.
    - b. The amount in AIC 806 on the previous statement of account.

- Research and correct any discrepancies before submitting the statement of account.
- Upon receipt of the certified Forms 3238, make the appropriate entries using the stock-destroyed option on the IRT. The system automatically posts the total to AIC 511.

#### Stamp Distribution Network Offices

##### Post Offices (Statement of Account Offices)

1. Postmasters must complete these tasks:
  - Submit unsold migratory bird stamps to the SDN during A/P 8.
  - Prepares Form 17-TX in quadruplicate. Copies one and two are submitted with the stock, copy three supports the statement of account entry, and copy four is filed locally. This form is available from the SDN. Mark Form 17-TX "Bird Stock Return."
  - Records bird stamps shipped to AIC 502, Bird Stock Shipped. This entry is made when the stamps are shipped to the SDN.
2. The SDN records bird stamps received to AIC 010, Bird Stamps Received, and submits the bird stamps and Form 17-TX to the stamp stock return committee.
3. The stamp stock return committee completes these tasks:
  - Certifies the bird stamps for destruction and prepares Forms 3238.
  - Reports any problems or discrepancies to the district accounting office for resolution.
  - Submits the completed Forms 3238 to the SDN manager.
4. The SDN manager completes these tasks:
  - Records the bird stamps destruction to AIC 511 on the statement of account.
  - Submits the signed original Forms 3238 and statement of account to the Minneapolis Accounting Service Center (MNASC).

#### Stations and Branches, Standard Field Accounting Procedures Offices, and Contract Stations (three-digit units IDs in SFAS)

Stations and branches and SFAP offices must submit unsold migratory bird stamps to the SDN during A/P 8.

1. Post office performs these tasks:
  - Prepares Form 17-TX in quadruplicate. Submits copies one and two with the stock; copy three supports the Form 1412 entry, and



- copy four is filed locally. This form is available from the SDN. Mark Form 17-TX "Bird Stock Returned."
- Records bird stamps shipped to AIC 848. This entry is made when the stamps are shipped to the SDN.
  - Ships bird stamps and Form 17-TX to the SDN.
2. The SDN completes these tasks:
    - Records bird stamps received to AIC 010, Bird Stamps Received.
    - Submits the bird stamps and Form 17-TX to the stamp stock return committee.
  3. The stamp stock return committee performs these tasks:
    - Certifies the bird stamps for destruction and prepares Forms 3238 from Form 17-TX.
    - Submits Forms 3238 to the SDN manager.
  4. The SDN submits the Form 17 summary to the district accounting office.
  5. The district accounting office completes these tasks:
    - Enters the amount on the Form 17 summary to AIC 502.

- Resolves any discrepancies between the amounts listed on the Form 17 summary to the amounts listed in AIC 848 for bird stock return.
6. Then the SDN completes these tasks:
    - Records the destruction to AIC 511.
    - Submits the signed original Form 3238 with the statement of account to MNASC.

Those offices designated as philatelic outlets are the only offices that should have an entry in AIC 806 on the A/P 9 or PQ III statement of account. These offices should list these bird stamps by year of issue and face value in the remarks section of the statement of account.

In summary, follow these guidelines:

- Post offices served by the SDN: enter bird stamps returned to AIC 502.
- SFAP offices served by the SDN or SDO: enter bird stamps returned to AIC 848.
- Post offices served by the SDO: enter bird stamps destroyed to AIC 511 upon receipt of the original Form 3238 from the SDO.

## IMM CORRECTION

### WORLDPOST Priority Letter

The following corrections are made to the *International Mail Manual* (IMM) revision published in *Postal Bulletin* 21889 (3-16-95) as IMM 226, WORLDPOST Priority Letter. These corrections (noted in the chart below) reflect minor substantive and editorial amendments incorporated into the interim rule published in the *Federal Register* on March 17, 1995 (60 FR 14370–14371). #### 226.12 Permissible Items

All items admitted in letters (see 221.1) are accepted in WPL as long as the contents fit securely into the WPL envelopes provided by the Postal Service. WPL items may contain dutiable merchandise unless the country of destination prohibits dutiable merchandise in letters (see 224.51). However, WPL items that contain dutiable merchandise might experience delay in delivery caused by customs handling.

#### 226.13 Addressing

See 122. All items must bear the complete delivery address of the addressee and the full name (no abbreviations) of the destination country.

#### 226 WORLDPOST Priority Letter

##### 226.1 General

##### 226.11 Definition

WORLDPOST Priority Letter (WPL) is an expedited airmail letter service providing fast, reliable, and economical delivery of all items mailable as letters. WPL items receive priority handling in the United States and in destination countries. Service is available only to destination countries

#### 226.3 Mailing Locations

##### 226.31 Acceptance Offices and Pickup Service Locations

WPL service is available only through the designated post offices listed in 226.32. WPL items must not be accepted or deposited in areas not listed in 226.32.

##### 226.32 Service Areas

Service is available only from the metropolitan areas as defined by the ZIP Code ranges shown below. Within these service areas, prepaid items may be given to carriers, deposited in Express Mail collection boxes, or mailed at post offices, stations, and branches. Pickup service is available.

**226.42 Pickup Service**

On-call and scheduled pickup service are available for WORLDPOST Priority Letters for a charge of \$4.95 for each pickup stop, regardless of the number of pieces picked up. Only one pickup fee is charged if domestic or international Express Mail, domestic Priority Mail, or domestic or international parcel post is picked up at the same time. (See DMM D010 for standards for pickup service.)

**226.43 Postage Payment Methods**

Postage for WORLDPOST Priority Letters may be paid by adhesive stamps, postage meter and meter stamps, or, if presented at a post office, postage validation imprinter (PVI) labels.

**226.5 Packaging**

Items must be placed in special WORLDPOST Priority Letter envelopes provided by the Postal Service. All items that cannot be adequately protected by these envelopes should not be mailed using this service. Envelopes must be sealed.

**226.6 Size and Weight Limits**

**226.61 General**

Two sizes of envelopes are available from the Postal Service for mailing WPL items. Postage rates are based on the size of the envelope used, not the weight of the item. (See 226.41 for rates.)

**226.62 Size Limits**

Sizes of the required Postal Service-provided envelopes are:

- a. Small size—5 inches by 8 7/8 inches.
- b. Large size—9 inches by 11 1/2 inches.

**226.63 Weight Limits**

The Postal Service-provided envelopes are not intended to accommodate items weighing more than several ounces. However, the maximum weight for letter-class (LC) items is 4 pounds.

**226.7 Customs Forms Required**

If WORLDPOST Priority Letters contain dutiable merchandise, the sender must prepare a customs declaration and affix it to the letter. See 123 for instructions. Certain nonpostal export forms may be required as described in Chapter 5.

**226.8 Special Services**

Mailers may obtain certificates of mailing (see 310). No other special services such as registry, insurance, restricted delivery, return receipt, or recorded delivery are available.

## Pictorial Cancellations Announcement 95-8

As a community service, the Postal Service offers pictorial cancellations to commemorate local events celebrated in communities throughout the nation. A list of upcoming events for which pictorial cancellations are authorized appears below. If available, the sponsor of the pictorial cancellation appears in italics under the date. Also provided, as space permits, are illustrations of those cancellations that were reproducible and available at press time.

People attending these local events may obtain the cancellation in person at the temporary post office station established there. Those who cannot attend the event, but who wish to obtain the cancellation, may submit a mail order request. Pictorial cancellations are available only for the dates indicated, and *requests must be postmarked no later than 30 days following the requested pictorial cancellation date.*

All requests must include a stamped envelope or postcard bearing at least the minimum First-Class Mail postage

(32 cents per envelope or 20 cents per postcard). Items submitted for cancellation may not include postage issued after the date of the requested cancellation. Such items will be returned unserved.

Customers wishing to obtain a cancellation should affix stamps to any envelope or postcard of their choice, address the envelope or postcard to themselves or others, insert a card of postcard thickness in envelopes for sturdiness, and tuck in the flap. Place the envelope or postcard in a larger envelope and address it to: PICTORIAL CANCELLATIONS, followed by the NAME OF THE STATION, ADDRESS, CITY, STATE, ZIP + 4 CODE, exactly as listed below (using all capitals and no punctuation, except the hyphen in the ZIP + 4 code).

After applying the pictorial cancellation, the Postal Service returns the envelope or postcard through the mail. Customers who want their serviced item returned under protected cover should include a larger, stamped, self-addressed envelope.

## New Distribution for *Stamps etc.* Catalog

Efforts to provide a comprehensive automatic distribution of *Stamps etc.* (the quarterly philatelic mail-order catalog) based on office size or revenue have not been successful, and many offices continued to get either too few or too many copies. At the suggestion of post offices and the stamp distribution and stamp marketing task forces, extra supplies of the catalog will be centralized at the material distribution centers (MDCs) so that local offices can order what they need, when they need it.

Due to rising costs, the initial automatic distribution is being reduced to avoid waste or excess copies at any office. Instead of being distributed through the accountable paper system, the catalog will be distributed through the MDCs in Somerville, NJ, and Topeka, KS. Effective with the April/May/June 1995 issue of *Stamps etc.*, other changes include the following:

- *Stamps etc.* will be identified as Publication 9 for inventory and distribution purposes.
- All post offices will receive a single copy for information and customer reference.

- All CAG A offices will receive a carton of 150 catalogs.
- All CAG B–K offices will receive a pack of 25 catalogs.
- Additional quantities beyond the initial distribution must be ordered from the designated MDC.
- Through the MDCs, the minimum quantity will be a shrink-wrapped package of 25; cartons will contain 6 packs of 25, or 150 catalogs.

Remember that the purpose of the catalog is to encourage mail orders for items not available to customers locally. It is not intended to substitute for a price list or inventory listing for customers making purchases in post offices. To that end, offices are encouraged to base their orders purely on customer needs as a guide. Using the catalog at temporary stations or stamp shows is also appropriate.

Customers wanting more than eight boxes of 50 should take advantage of the volume pricing for boxes of 500.

**Additional Supply**

Each accountable paper depository (APD) will receive 1,680,000 stamps, with the exception of Denver, CO, which will receive 840,000 stamps; the stamp distribution networks will receive 1,540,000 stamps for filling supplemental orders. SDOs requiring additional stamps must order them from their APD, using a separate Form 17, *Stamp Requisition*. All other post offices requiring additional stamps should requisition them from their designated SDO on a separate Form 17, or designated SDN on a separate Form 17sx, *Accountable Items Requisition Stamp Distribution Network*.

**Sales Policy**

These stamps should be available at regular service windows until they are officially removed from sale, generally 1 year from date of issue. All post offices must initially acquire at least a 60-day supply of each new commemorative stamp before the sale date and have the stamps available at all service windows on the sale date. If supplies run low, post offices must reorder additional quantities through their normal ordering procedures.

## Thrift Savings Plan—New Procedure for Filing Designation of Beneficiary Form

### Change in Procedure

As stated in the December 22, 1994, *Postal Bulletin* article "Thrift Savings Plan Policy Changes," beginning January 1, 1995, a Thrift Savings Plan (TSP) participant who wishes to name a beneficiary for his or her TSP account must file Form TSP-3, *Designation of Beneficiary*, directly with the TSP Service Office in New Orleans, LA. Personnel services offices *must no longer* accept Forms TSP-3 from participants.

Personnel services offices are not required to search all career employees' Official Personnel Folders (OPFs) for existing Forms TSP-3, contrary to the instructions in a *TSP Bulletin* recently published by the Federal Retirement Thrift Investment Board (the independent agency that administers TSP). However, whenever an employee separates, the personnel services office must search the employee's OPF and send all Forms TSP-3 to the TSP Service Office. Also, personnel service offices may remove Forms TSP-3 from employees' OPFs and send the forms to the TSP Service Office prior to the date of separation.

### Notice to Employee

To assist in publicizing this change in procedure, post the notice on page 57 on all bulletin boards through May 12, 1995. In addition, Headquarters Compensation

and Benefits will be mailing a notice outlining this new procedure to all career employees, to arrive no later than early May 1995. To save on mailing costs, this mailing will be combined with the mailing of TSP-0595, *Open Season Update: May 15, 1995–July 31, 1995*.

### Automatic Distribution of Form TSP-3

Although an automatic distribution of the November 1994 edition of Form TSP-3 was made in December 1994, the material distribution centers (MDCs) are automatically distributing an additional supply of Form TSP-3 to Human Resources personnel at customer services district offices, area offices, processing and distribution centers, bulk mail centers, airport mail centers, remote encoding centers, Headquarters, and selected Headquarters field units.

### TSP Open Season

The new designation of beneficiary procedure discussed above is separate from the semiannual TSP open season, which will be held May 15, 1995, through July 31, 1995. TSP open season procedures and the distribution of materials will be discussed in a forthcoming *Postal Bulletin*.

- An additional white woven mesh sunhelmet became available for eligible special delivery messenger craft personnel on March 1.

- A new blue craft tab has been designed and approved for application on the bomber jackets worn by eligible special delivery messenger craft personnel. The new blue color replaces the current navy blue tab and coordinates with the new corporate logo. ### What Is Form TSP-3?

---

Form TSP-3, *Designation of Beneficiary*, is used if you wish to designate a beneficiary for your Thrift Savings Plan (TSP) account.

### Send New Form to TSP Service Office

---

The Federal Retirement Thrift Investment Board (Thrift Board), an agency independent of the Postal Service, recently assumed responsibility for validating and maintaining Forms TSP-3. The Thrift Board's TSP Service Office will administer this process.

If you previously submitted Form TSP-3 to your personnel services office, the Postal Service is advising you to complete a *new* Form TSP-3 and send it immediately to the TSP Service Office at the address on the form.

### TSP Validates Form

---

Upon receipt, TSP will make sure you have completed your Form TSP-3 properly and that it is valid.

### Where Can I Get a New Form?

---

Your personnel services office will provide you with a blank Form TSP-3 upon request. Make sure it is dated 11/94 or later in the lower right-hand corner.

### Is More Information Available?

---

Yes. You will be receiving a notice in the mail on this new procedure. It will be included with the TSP open season update pamphlet that is mailed to all career employees.
