Olympic Logo — Removal Reminder

Headquarters General Counsel continues to receive frequent contacts from the United States Olympic Committee concerning the unauthorized display and use of the Olympic logo. General Counsel has recommended that we reissue the reminder notice, which first appeared in *Postal Bulletin* 21883 (12-22-94).

All field managers are reminded that the U.S. Postal Service is no longer an Olympic corporate sponsor. As such, it is not licensed to display the Olympic logo (inclusive of Olympic marks, symbols, or terminology) on any of its equipment, buildings, packaging, or stationery items.

All offices must immediately survey their areas of responsibility for these logos and arrange for their removal. Likely locations of these logos include collection boxes, postal vehicles, entry doors to both post office box and retail lobbies, and display posters. Terminate immediately all use of stationery and packaging items (letterhead, envelopes, pens, pins, etc.) displaying the Olympic logo.

Delivery Bar Code Sorter Label Ordering Procedures

Two indefinite delivery, indefinite quantity contracts have been extended for delivery bar code sorter (DBCS) labels. Use these labels only with Martin Marietta and ElectroCom DBCSs. They have been tested and approved by the Postal Service Engineering Center. Labels from

other suppliers have not been tested and often fail to perform properly in mail sorting operations.

Intermec Media Products is the mandatory source of supply for rolled labels. Barcodes West, Inc., is the mandatory source of supply for fan-fold labels.

DMM CORRECTION

Labeling List DMM L707

Effective retroactively to November 23, 1995, *Domestic Mail Manual* (DMM) L707, Originating Mixed-States — Third- and Fourth-Class Irregular Parcels, corrects a typographical error published in *Postal Bulletin* 21907 (page 5). The correction is printed below.

The “Change To:” label for ZIP Codes 060–069 should be corrected from “MXD SOUTHERN CT 064” to “MXD HARTFORD CT 060.”

Express Mail Service Directory — Distribution of IRT Update Diskettes

All post offices that use UNISYS II, UNISYS III, or MOS integrated retail terminals (IRTs) to accept Express Mail should receive *on or about December 8* an Express Mail directory update diskette from UNISYS or MOS. If more than one type of IRT is used for Express Mail, offices should receive a separate diskette for each type. If an office has a weighing and rating unit (WRU), it should receive a UNISYS III or WRU diskette to update the directory on the WRU.

The Express Mail network on the diskette is *effective immediately*. Install the Express Mail service directory on your IRT diskettes and WRUs at once (instructions for updating are included with the diskette). Also enclosed with the diskette is a form to complete and send to your expedited service specialist indicating receipt and updating of

the Express Mail directory on your IRT diskettes and WRUs.

If your office did not receive the appropriate type of IRT diskettes for the IRTs or WRUs at your office, *immediately* contact your expedited service specialist (Express Mail office). If you have difficulty loading the directory from the diskettes you receive, contact the IRT vendors hotline:

HANDBOOK PO-502 REVISION

Sleeving and Strapping of MM Trays

Currently, Handbook PO-502, Container Methods, does not require managed mail (MM) trays to be sleeved, covered, or strapped prior to dispatch when these trays will be transported on USPS-owned or operated equipment. If these trays are to be transported using contractor owned or operated equipment (for example, HCRs), Handbook PO-502 requires that the trays be strapped.

In many areas of the country, MM trays on HCRs are no longer being strapped. This is especially true when postal employees dispatch automated zone mail from plants to post offices that perform their own delivery point distribution. However, strapping may still be necessary when dispatching MM trays between plants and BMCs to facilitate mechanized handling at the destination.

In order to reflect policy changes in requirements for strapping MM trays, section 264.523 of Handbook PO-502 is revised effective immediately. Make a handwritten change to page 77 of the handbook as follows:

Chapter 2, Container Descriptions and Applications

* * * * *

260 Special Purpose Containers

* * * * *

264.52 Strapping Trays

* * * * *

264.523 All MM trays that will be transported by commercial or network air carrier must be sleeved and strapped before dispatch (see Handbook PO-507, Air Contract Administrative Procedures, chapter 3). MM trays transported by USPS-owned and operated or contract surface transportation need not be sleeved or strapped when dispatched to intra-area destinations depending on the type of wheeled transport container used. MM trays transported by USPS-owned and operated or contract surface transportation need not be strapped when dispatched to Inter-area destinations depending on the type of wheeled transport container used.

Note: Local management must ensure that whichever method is used that the security and facing orientation of the mail will be maintained.

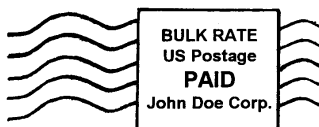

Acceptance of Permit Imprints With “Killer Bars”

The changes to Domestic Mail Manual (DMM) P040, published in Postal Bulletin 21892 (4-27-95), now allow mailers a greater degree of flexibility in designing permit imprints. Under the new rules, which relaxed and expanded DMM P040, mailers may incorporate a distinctive design if they so desire. As an example, a church might display its required permit imprint wording inside the graphic outline of a church steeple, or a commercial business might print its logo to the left of the indicia.

Although DMM P040.4.2 now provides for the use of an imprint with such an optional format, it specifically prohibits extraneous printing within, above, or to the right of a permit imprint. The application of P040.4.2d by bulk mail acceptance personnel has caused problems for a limited group of mailers who have been using a permit imprint design that includes wavy lines resembling cancellation bars, commonly referred to as “killer bars.” This design looks similar to the following:



The new rules were put into place to allow customers some flexibility while protecting USPS interests in maintaining easily recognizable permit imprints, which is critical to ensuring proper revenue collection. However, because the potential operational problems associated with temporarily continuing to accept “killer bar” imprint formats appear to be limited, acceptance personnel are directed not to reject bulk mailings solely because they are printed with this format. Instead, acceptance personnel are to alert such customers of the new requirements and advise them that the bars appearing to the right of the imprint should be removed with their next printing in order to meet the requirements of DMM P040.4.2. As information, bars appearing to the left side of the permit imprint are permissible under P040.4.2f.

1995 IRS Tax Package

Contract mailers for the Internal Revenue Service (IRS) will begin mailing the 1995 tax package during the week of December 26, 1995. Accepting offices must verify and accept these mailings, which bear IRS permit imprint number G-48, if they are prepared correctly for third-class bulk rates (carrier route, five-digit, and basic).

Deliver this material upon receipt as requested by the IRS.

In addition to the tax package booklets that normally make up this mailing, the IRS will also make a separate mailing on December 13, 1995, of 25 million postcards to taxpayers who use a tax preparer. The postcards are third-class, sorted to carrier routes. Carriers should deliver these postcards when they are received.

Accepting Offices

The IRS contract mailers will prepare the tax packages for mailing at the third-class carrier route presort rates. The packages must meet all preparation and makeup requirements in the *Domestic Mail Manual* (DMM). Offices must verify that the tax package mailings are prepared according to the presort requirements current at the time of mailing. They must weigh and verify mailings unless the rates and classification service center (RCSC) serving the post office of mailing authorizes an optional procedure for that contract mailer. (Supporting paperwork for the optional procedure must be provided at the time of mailing.) This verification ensures that the rate and piece counts claimed on the mailing statements are accurate and that the IRS has paid the correct postage. The RCSC must approve each printer's site individually for manifesting.

Tax packages 1040-3, 1040-8, and 1040-9 will be manifested.

Bulk Mail Centers

Transfer Pallets. Bulk mail centers (BMCs) will receive pallets labeled to five-digit, three-digit, and sectional center facilities (SCFs), as well as sacks for BMC destinations. Dispatch the three-digit, five-digit, and SCF pallets intact to their appropriate destinations.

Distribution of Pallets. Upon receipt of the BMC pallets at the BMC destinations, break open the pallets and distribute. The destination for each sack is on the sack label. For example:

WASHINGTON DC 20224
3C FLATS CR 18
FLORENCE KY

Dispatch the packages, sacks, and bundles of tax packages to the destination facilities for distribution to the delivery units.

Delivery

Tax packages should be delivered upon receipt as requested by the IRS.

Errors and Irregularities

Pay particular attention to errors in makeup at the point of delivery. When carrier route presort errors exceed the five percent allowance, deliver the mail and use established reporting procedures to report errors to the following address:

Address Label Position

The IRS is authorized to put the address label on tax packages upside down in relation to the return address and the endorsement. This placement facilitates sortation into vertical flat cases and allows the label to be visible when placed in the carriers' satchels.

The packages with the address at the top of the package will not be upside down, as requested by some postmasters.

Report other irregularities to the Manager, Post Office Accounting by memorandum or at USPS Headquarters, on Form 3749, *Irregularities in the Preparation of Mail Matter*.

Forwarding and Return

Form 3575, Change of Address Order, on File. Packages marked Form 1040 and 1040A-2 (but not 1040A and 1040EZ) are endorsed "Forwarding and Return Postage Guaranteed."

Note: Tax packages other than those marked Form 1040 and 1040A-2 will not be endorsed "Forwarding and Return Postage Guaranteed" and must not receive forwarding and return service. Treat tax packages that are undeliverable-as-addressed (UAA) and endorsed "Forwarding and Return Postage Guaranteed" as specified in DMM F010.4.0 and DMM Exhibit F010.5.3.

No Form 3575 on File. When a Form 1040 and 1040A-2 tax package (but not 1040A and 1040EZ) endorsed "Forwarding and Return Postage Guaranteed" is UAA and no Form 3575 is on file, return the entire tax package to the IRS along with the reason for nondelivery. Do not remove the address label because the IRS needs both the label and the tax package to which it is attached.

Personnel must be sure that tax packages declared undeliverable are in fact undeliverable, especially packages endorsed as "No Such Number" or "Insufficient Address." The IRS expressed concern about the high number of pieces erroneously returned as UAA.

Note: Return only UAA tax packages Forms 1040 and 1040A-2 to the IRS (but not Forms 1040A and 1040EZ). Do not treat any Form 1040 or 1040A-2 UAA tax packages as waste *under any circumstances*. Return undeliverable tax packages Form 1040 and 1040A-2 (but not 1040A and 1040EZ) to:

Note: Tax packages other than those marked Form 1040 or 1040A-2 will *not* be endorsed "Forwarding and Return Postage Guaranteed" and must *not* receive forwarding or return service. They must be treated as waste. Do not commingle other IRS mail bearing the above address with returned tax packages.

Return Postage Charges

See DMM F010.4.3. Do not collect postage for tax packages returned to the IRS. The Manager, Post Office Accounting, at USPS Headquarters collects return postage on a national basis. *Do not try to collect a fee from either the IRS or a postal customer.*

Distribution and Delivery Workhours

The Postal Service is committed to delivering the tax packages as close to (but not later than) the requested delivery date as possible. Offices must accomplish the distribution and delivery of the tax packages *using normal and prudent workload management procedures.*

INTERNATIONAL MAIL

IMM AND PUBLICATION 273 REVISION

Express Mail International Service — Malaysia

Effective immediately, Express Mail International Service (EMS) to Malaysia will require the following customs forms:

Customs declaration/endorsements: No form is required for business correspondence, commercial papers, and documents. Next to mailing list label, clearly endorse item BUSINESS PAPERS. Use Form 2976, *Customs — Douane C1* (green label), for merchandise samples without commercial value and not subject to customs duty. Use

Form 2966-A, *Parcel Post Customs Declaration — United States of America*, for merchandise and all articles subject to customs duty. Include commercial invoice in each item. The invoice must be placed on the EMS item.

Issue 16 of the *International Mail Manual (IMM)* and the next edition of Publication 273, *Express Mail International Service Guide*, will include these changes.

HANDBOOK F-1 REVISION

Permit Mailings — Nonsufficient Fund Checks

Effective January 1, 1996, the collection procedures will change for checks used to pay postage on permit imprint mailings that are returned for insufficient funds (NSF). The current procedure is described in *Postal Bulletin* 21838 (4-1-93, page 22). The writer of the NSF check for bulk mailings is solely liable. The Postal Service will no longer pursue collection efforts against the permit holder unless the permit holder is also the writer of the check. Accordingly, the check collection procedures for NSF checks follow.

The Postal Service submits returned checks to the check collection agency as described in *Postal Bulletins* 21810 (3-5-92) and 21822 (8-20-92). This is the same policy used for all checks returned by banks as NSF. Handbook F-1, *Post Office Accounting Procedures*, section 311.2, describes the check acceptance policy. Postmasters must take reasonable measures to ensure that checks submitted in payment are written by reliable firms, especially if this is the first presentation of that firm's check by a permit holder or presenter of a mailing. The method of determining the reliability of a check is made locally. Depending on the local method used to determine reliability, postmasters should advise permit holders and presenters of mailings that mailings may be held temporarily when the check used for payment must be verified for reliability. Mailers should also be advised that writers of NSF checks will be denied the privilege of using checks to pay for future postal charges and services unless a postmaster, based on personal knowledge of a case, waives or places a time limit on the denial of check acceptance privileges.

If the writer of the NSF check is the permit holder, the Postal Service, after notification, reserves the right to reduce the permit holder's account by the amount of the NSF check and applicable surcharge if the permit holder does not pay upon demand. If the amount in the permit holder's account does not cover the whole amount of the NSF check, the remainder of the amount owed is treated as a revenue deficiency. The procedures for handling revenue deficiencies are in Management Instruction MI-DM-140-89-2, *Collecting Revenue Deficiencies*, June 16, 1989.

Handbook F-1, *Post Office Accounting Procedures*, is revised as follows:

Chapter 5 Other Retail Activity

* * * * *

520 Mail Without Postage Affixed

* * * * *

522.1 Accepting Payments. Payment is made at time of mailing or through an advance deposit account. Checks accepted at Bulk Mail Entry Units (BMEUs) must have "BMEU" recorded on the front of the check. Postmasters will apply their usual criteria for business check acceptance from new permit holders and clients of permit holders. Examine checks before acceptance to be sure that the payee is either the U.S. Postal Service or the Postmaster.

* * * * *

522.3 Collecting on NSF Checks. The Postal Service may contact the check writer on returned checks or may immediately submit NSF checks to a collection agency after a second deposit attempt. NSF checks are submitted to the check collection agency for collection without further collection efforts by the Postal Service. Collection efforts will be pursued only against the writer of the check, whether the permit holder or client of the permit holder.

522.4 Additional Collection Alternatives. If the writer of the NSF check is the permit holder, the Postal Service, after notification, may reduce the permit holder's account by the amount of the NSF check and applicable surcharge if the permit holder does not pay upon demand. If the amount in the permit holder's account does not cover the whole amount of the NSF check, the remainder of the amount owed is treated as a revenue deficiency. The procedures for handling revenue deficiencies are in Management Instruction MI-DM-140-89-2, *Collecting Revenue Deficiencies*, June 16, 1989.

Prepaid Ticket Advices

Effective October 1, 1995, postal travelers are prohibited from using the prepaid ticket advice service except in cases of emergency. All tickets must be dispensed by travel agencies unless the flight is being booked less than one business day before departure.

Beginning October 1, 1995, airlines began charging federal (including Postal Service) travelers a fee for using their prepaid ticket advice service. Prepaid ticket advice is a service provided by the airlines that allows travel agencies to

reserve an airline ticket that is issued not by the travel agency but by the airline at the airport prior to takeoff. Charges for this service will be between \$25 and \$45 per ticket.

All Area Finance Offices, the Technical Training Center, and the Raleigh ISSC should ensure that their travel agencies are aware of this policy change.

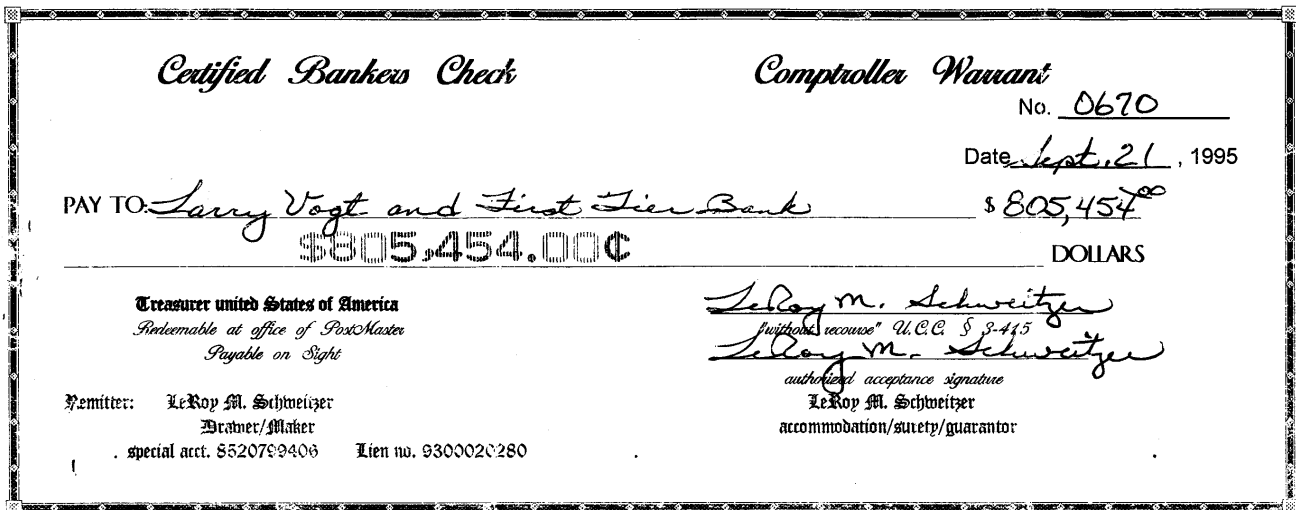

Changes to Uniform and Work Clothes Programs — 1994–1998 USPS-APWU National Agreement

Uniform Allowances

Employees covered under the 1994–1998 USPS-APWU National Agreement who are eligible to receive annual clothing allowances, as specified in *Employee and Labor Relations Manual* (ELM) 932.1, are entitled to an increased annual allowance of 10 percent, effective on allowance anniversary dates occurring on or after October 1, 1995, as follows:

To achieve maximum benefit from the increased uniform allowance, employees whose next uniform allowance date falls between October 1, 1995, and the effective date of updating by the St. Louis Information Service Center may wish to wait to make purchases until they have received their Form 1961, *Employee Uniform Allowance*

Statement, which will reflect the increased amount. Allowances will be updated as anniversary dates fall due.

Work Clothes Program and Contract Program Combined

As the result of 1994 contract negotiations between the USPS and American Postal Workers Union, it was agreed to combine the current work clothing and contract clothing programs into one Work Clothes Program. Eligibility based on the established ELM criteria remains as outlined in ELM 932.12 and 932.13.

In combining the two programs, the clothing items authorized under each of the programs will be available for purchase by all employees in the Work Clothes Program. The following certified postal work clothes garments may be purchased by those employees eligible for the above-listed Work Clothes Program allowance amounts:

- Jacket (utility)
- Trousers (dark blue twill)
- Vest (insulated)
- Sweatshirt (hooded)
- Sweater
- Shirt (light or dark blue, long or short sleeve)
- Coveralls
- Baseball cap or fur trooper cap
- Shoes (black regulation approved SR/USA)

All official postal work clothing bears a new corporate work clothing emblem.

1996 Requisition Schedule: Postage Stamps and Postal Cards

Postmasters of all CAG A–G post offices should submit Form 3356, *Stamp Requisition — Bulk Quantities* (NSN 7530-03-000-0904), to the Bureau of Engraving and Printing, and Form 3216, *Requisition for Postal Cards — Bulk Quantities* (NSN 7530-02-000-9821), to the Government Printing Office according to the schedule below. Offices should mail requisitions for postage stamps in the pre-addressed Envelope EP-10A (NSN 7530-01-364-2359), and requisitions for postal cards in the preaddressed Envelope EP-10C (NSN 7530-01-364-7064). These envelopes can be ordered from the material distribution centers. Order only those postage stamps manufactured by the BEP on Form 3356.

Requisitions to the BEP and the GPO must be mailed at least 7 days before the due date in the schedule below

to allow time for processing. Shipments begin about 10 days after the scheduled due date.

Requisitions for postage stamps that are received after the scheduled date are processed out of cycle, which increases processing and handling costs and delays shipments for the ordering post office. Requisitions for postal cards that are received after the scheduled date are processed during that area’s next cycle.

This schedule does not apply to requisitions for precanceled stamps. Emergency and precanceled stamp orders are shipped 10 days after receipt at the BEP. Insert a copy of this updated schedule into Handbook F-48, *Bulk Requisitioning and MSC Accountable Paper Functions*, as Exhibit 241.2. Note that the BEP will be closed for Christmas from December 25, 1996, through January 1, 1997.

STAMP ANNOUNCEMENT 96-1

Utah Statehood Commemorative Stamp



The Postal Service commemorates the 100th anniversary of the admission of Utah into the Union with the issuance of a 32-cent stamp (Item 4402) on January 4, 1996, in Salt Lake City, Utah. The stamp goes on sale nationwide January 5.

Designed by McRay Magleby of Provo, Utah, the stamp features the Delicate Arch, a geologically formed arch that frames the La Sal Mountains. The Arch, located in Arches National Park, is one of the most familiar icons in the state.

On January 4, 1896, Utah became the nation's 45th state. Salt Lake City, its capital, is located in the north central part of the state. Utah's landscape is formed primarily by mountains, high plateaus, and deserts and straddles three physiographic regions: the Middle Rockies, the Basin and Range Province, and the Colorado Plateau. The climate is basically arid, except for the southwestern corner, which is almost dry subtropical.

How to Order the First Day of Issue Postmark

Customers have 30 days to obtain the first day of issue postmark by mail. They may purchase the new stamps at their local post office, affix the stamps to envelopes of their choice, address the envelopes (to themselves or others), and place them in a larger envelope addressed to:

After applying the first day of issue postmark, the Postal Service returns the envelopes through the mail. There is no charge for the postmark. All orders must be postmarked by February 3, 1996.

The Philatelic Fulfillment Service Center also offers first day covers for new stamp issues and postal stationery items postmarked with the official first day of issue cancellation. Each item has an individual catalog number and

First day covers remain on sale for at least 90 days after the stamp's issuance.

Stamp Distribution

All stamp distribution offices (SDOs) and stamp distribution networks (SDNs) will receive an initial automatic distribution of half their standard distribution for a 50-stamps-per-pane issue, rounded to the nearest master carton size (125,000 stamps). SDOs and SDNs will make subsequent automatic distributions to post offices, using Form 3309, *Advice of Shipment/Stamp Invoice*, and Form 17, *Stamp Requisition*. SDOs and SDNs must not distribute stamps to post offices before December 27, 1995. The accountable paper depositories (APDs) in San Francisco,

California, and Denver, Colorado, will each have 2,000,000 stamps as back-up quantities and the Salt Lake City, Utah, SDO will have 5,000,000 stamps as back-up. For the vending program, 3,000,000 stamps will be provided as 200,000 packets of 15 stamps. Packets will be sent to the Salt Lake City, Utah, SDO for statewide distribution only.

Philatelic Requirement

Stamp distribution offices with authorized philatelic centers will receive their standard automatic distribution for subsequent distributions to each center.

Sales Policy

All post offices must acquire and maintain a supply of each new commemorative stamp as long as customer demand exists or until the stamp is officially withdrawn from sale, generally 1 year from the date of issue. If supplies run low, post offices must reorder additional quantities through their normal ordering procedures.
