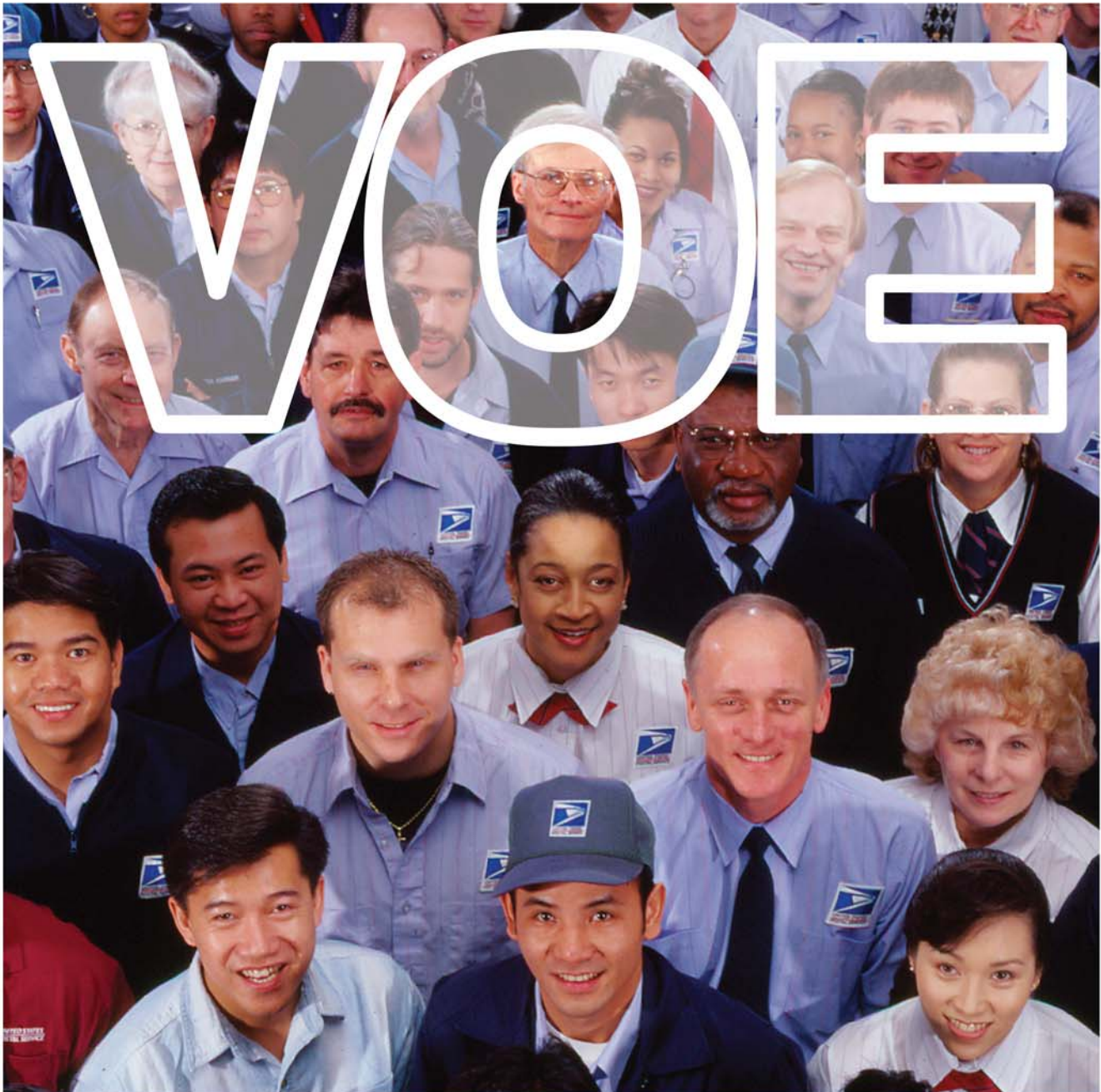

DMM Revision: Clarification of Standards Relating to Mailpieces Bearing a Simplified Address

Effective August 3, 2009, the Postal Service™ is revising *Mailing Standards of the United States Postal Service*, Domestic Mail Manual (DMM®) 245.68 and 345.69 to provide clarification relating to delivery sequence standards for mailpieces bearing a simplified address.

Current standards describe the requirement for the periodic updating of walk sequence information for mailpieces prepared with a simplified address. For these mailpieces, this requirement is fulfilled through the acquisition of current delivery statistics information.

DMM Revision: New Polywrap and Deflection Standards for Commercial Flat-Size Mail

Effective September 8, 2009, the Postal Service™ is revising *Mailing Standards of the United States Postal Service, Domestic Mail Manual (DMM®)* 301.1 and 301.3.2.1 to adopt new polywrap and deflection standards for flat-size commercial mail of all classes, as published April 6, 2009, in our *Federal Register* final rule (74 FR 15380–15384).

Polywrap standards, currently applicable only to automation flats, will apply to all flat-size mailpieces using polywrap, except saturation and high-density Periodicals or Standard Mail® flats. We originally proposed to implement this broader application of polywrap standards on May 11, 2009, but chose to delay implementation to allow mailers who have not been using approved polywrap more time to transition to the new standards. Detailed specifications for polywrap approved for use on flats, as well as a list of approved products, are available at <http://ribbs.usps.gov>; click *Site Index by Topic* in the upper frame, and then under “RIBBS™ Links (cont.)”, *Polywrap Manufacturers*.

The polywrap selvage (overhang) will be included on a polywrapped flat when measured for maximum dimensions. However, we increase the maximum length of a polywrapped flat to 15.75 inches (inclusive of selvage) from the current 15 inches to accommodate additional selvage for larger publications. We continue to allow no more than 1-1/2 inches of selvage in the length and no more than 1/2 inch in the height. We do not include selvage when measuring for minimum dimensions.

On September 8, 2009, we also will extend the deflection standards currently applicable to automation flats, to all flat-size mailpieces, except those mailed as saturation and high-density Periodicals or Standard Mail flats. The deflection standards change to allow 1 inch less of vertical deflection (droop) than is currently allowed. We eliminate the current exception for oblong flats (those with a bound edge on the shorter side) so all flats are tested with the length placed perpendicular to the edge of a flat surface. As a reminder, USPS® reduced the deflection standards in 2007, permitting up to a 4-inch drop for pieces at least 10 inches long. The new standards will allow a 3-inch drop for pieces at least 10 inches long, compared to a maximum of 2-3/8 inch drop before May 2007. Our difficulties in processing oblong flats, and those that come close to the current maximum deflection, made it clear that the reduction in 2007 was too extreme. Our delayed implementation has granted mailers the opportunity to make changes to slightly stiffen their “droopy” flats to meet the new standards.

We will be revising *Mailing Standards of the United States Postal Service, Domestic Mail Manual (DMM)* as explained here.

1.0 Physical Standards for Flats

1.1 General Definition of Flat Size Mail

Flat-size mail other than that in 3.0, Physical Standards for Automation Flats, is:

* * * * *

[Revise the text of item b as follows:]

- b. Not more than 15 inches long, 12 inches high, or 3/4 inch thick, except for:
 1. Periodicals mailed under 707.26.0.
 2. Polywrapped flats, with selvage that extends beyond the contents, up to a maximum length of 15-3/4 inches. The enclosed contents must not be longer than 15 inches.

1.2 Length and Height of Flats

[Revise the text of 1.2 by adding new third and fourth sentences about selvage as follows:]

***When determining the *maximum* height or length of a flat, include any selvage of polywrap material that may enclose the piece. When determining the *minimum* height or length of a flat, do not include the selvage of any polywrap material that may enclose the piece.

[Rename current 1.5 as new 1.7.]

[Move 301.3.2.3 in its entirety, rename as 1.5, revise heading and text to extend maximum deflection standards to all flat-size mailpieces, and delete item c as follows:]

1.5 Maximum Deflection for Flat-Size Mailpieces

Flat-size mailpieces must be flexible (see 1.3) and must meet maximum deflection standards. Flat-size pieces mailed as high density or saturation carrier route pieces are not required to meet these deflection standards. Test deflection as follows:

- a. For pieces 10 inches or longer (see Exhibit 1.5a):
 1. Place the piece on a flat surface with the length perpendicular to the edge of the surface and extend the piece 5 inches off the edge of the surface. Test square-shaped bound flats by placing the bound edge parallel to the edge. Turn the piece around and repeat the process.

- The piece is mailable as a flat if it does not droop more than 3 inches vertically at either end.

Exhibit 1.5a Deflection Test—Pieces 10 Inches or Longer

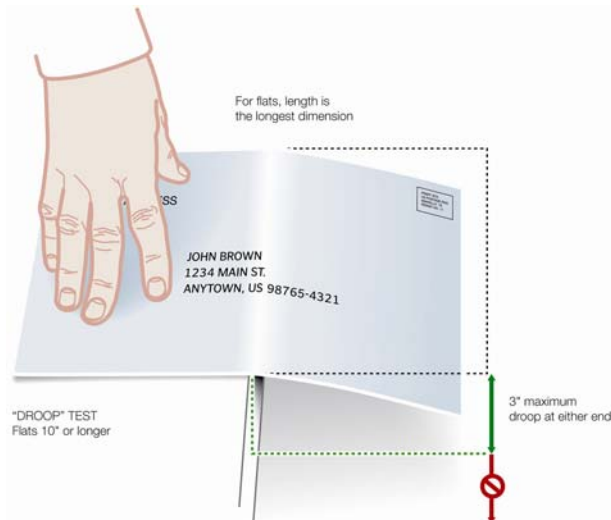
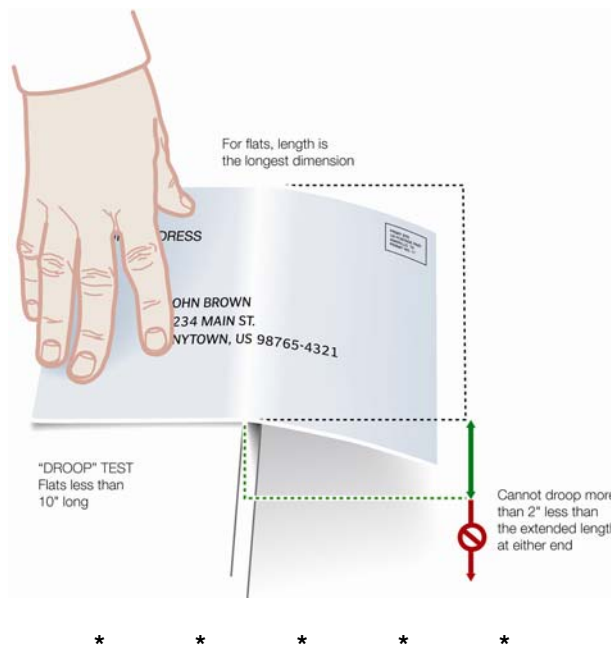


Exhibit 1.5b Deflection Test—Pieces Less Than 10 Inches Long



b. For pieces less than 10 inches long (see Exhibit 1.5b):

- Place the piece on a flat surface with the length perpendicular to the edge of the surface and extend the piece one-half of its length off the edge of the surface. Test square-shaped bound flats by placing the bound edge parallel to the edge. Turn the piece around and repeat the process.
- The piece is mailable as a flat if it does not droop more than 2 inches less than the extended length from both ends. For example, a piece 8 inches long would extend 4 inches horizontally off a flat surface. It must not droop more than 2 inches vertically at either end.

[Renumber current 301.3.4 in its entirety as new 1.6 and revise heading and text to extend polywrap standards to all flats as follows:]

1.6 Polywrap Coverings

1.6.1 Polywrap Films and Similar Coverings

[Revise renumbered 1.6.1 as follows:]

Mailers using polywrap film or similar material to enclose or cover flat-size mailpieces must use a product meeting the standards in 1.6. Polywrapped flat-size pieces mailed as high density or saturation carrier route pieces are not required to meet these polywrap standards. Film approved for use under 1.6.5 must meet the specifications in Exhibit 1.6.1 as follows:

- Films or similar coverings must meet all six properties in Exhibit 1.6.1.
- If the address label is affixed to the outside of the polywrap, the haze property (property 2) does not apply.
- Only products listed as approved on the USPS RIBBS Web site (<http://ribbs.usps.gov>) may be used on flat-size mailpieces.

Exhibit 1.6.1 Polywrap Specifications

[Revise the introductory sentence of renumbered exhibit 1.6.1 as follows:]

Mailers who polywrap flats, except for saturation and high density carrier route pieces, must use polywrap that meets all of the properties in this exhibit.

[Delete renumbered 1.6.4, Polywrap on Mailpieces, in its entirety and redesignate renumbered 1.6.5 to new 1.6.4.]

1.6.4 Polywrap Certification Process for Manufacturers

[Revise the first sentence of the introductory paragraph in 1.6.4 as follows:]

To ensure that all polywrap manufacturers use the same criteria, the Postal Service developed specification USPS-T-3204, *Test Procedures for Polywrap Films*. ***Manufacturers should follow this procedure before submitting the letter certifying compliance with the specifications:

[Revise item a as follows:]

- a. Test each film according to procedures listed in USPS-T-3204, *Test Procedures for Polywrap Films*.

1.7 Flat-Size Pieces Not Eligible for Flat-Size Prices

[Revise text of renumbered 1.7 as follows:]

Mailpieces that do not meet the standards in 1.1 through 1.6 are not eligible for flat-size prices and must pay applicable prices as follows:

- a. First-Class Mail—parcel prices.

- b. Standard Mail—Not Flat-Machinable or parcel prices.

- c. Bound Printed Matter—parcel prices.

3.2 Additional Criteria for Automation Flats**3.2.1 Shape and Size**

Each flat-size piece must be rectangular, except that flat-size mailpieces may have finished corners that do not exceed a radius of 0.125 inch (1/8 inch). See Exhibit 1.1c. The following minimum and maximum dimensions apply to First-Class Mail, Standard Mail, Periodicals (except under 707.26.0), and Bound Printed Matter pieces:

[Revise item b as follows:]

- b. Minimum length is 6 inches. Maximum length is 15 inches, except for polywrapped flats as allowed in 1.1.

DMM Revision: New Barcode Placement Standards for Automation Letters

Effective August 3, 2009, the Postal Service™ will revise *Mailing Standards of the United States Postal Service*, Domestic Mail Manual (DMM®) 202.5.3 and 507.9.8.1 to implement a more liberal barcode placement standard for mailers printing a barcode in the lower right corner of automation letters, barcoded carrier route letters, or Business Reply Mail® mailpieces. Mailers preparing courtesy reply mail or meter reply mail for enclosure within automation mailings may place barcodes on these pieces in accordance with this new standard.

In the past, mailers placing POSTNET™ or Intelligent Mail® barcodes in the lower right corner of automation and carrier route letters were required to place the barcode within an area between 3/16 inch and 7/16 inch from the bottom edge and between 3-1/2 inches and 4-1/4 from the right edge of the piece.

In response to requests from mailers, we will revise our standards to increase the upper limit of the allowable vertical placement for a POSTNET or an Intelligent Mail barcode placed in the lower right corner of an automation letter, carrier route letter, or Business Reply Mail mailpiece to 1/2 inch from the bottom of the mailpiece. This new standard will provide an additional 1/16 inch of vertical clearance for mailers choosing to print a barcode in the lower right of automation letters, carrier route letters, or Business Reply Mail mailpieces.

We will incorporate this revision into the next printed version of DMM and into the August update of the online DMM available via Postal Explorer® at <http://pe.usps.com>.

DMM Revision: Booklets: Sealing Letter-Sized Booklets Mailed at Automation Prices

On April 15, 2009, the Postal Service™ published a *Federal Register* final rule (74 FR 17399–17403) to reflect the construction and sealing of letter-sized booklets mailed at automation, presorted machinable or carrier route letter prices, effective September 8, 2009.

Also effective September 8, 2009, we are including the following additions to *Mailing Standards of the United States Postal Service, Domestic Mail Manual (DMM®)* 201.3.15.4 to:

- Clarify tab placement on small letter-size booklets.
- Clarify construction of mailpieces with glued flaps.
- Add one booklet sealing option.

1.1.3 All Machinable Letters

[Revise text of 1.1.3 as follows:]

All machinable letters must meet the standards for automation-compatible letters in 201.3.0.

3.0 Physical Standards for Machinable and Automation Letters and Cards

3.1 Basic Standards Automation Letters and Cards

[Revise text of 3.1 as follows:]

Letters and cards claimed at any machinable, automation, or Standard Mail carrier route price must meet the standards in 3.0. Unless prepared as a folded self-mailer, booklet, or postcard under 3.14 through 3.16, each machinable or automation letter must be a sealed envelope (the preferred method) or, if unenveloped, must be sealed or glued completely along all four sides.

[Delete current 3.4 through 3.6 in their entirety.]

[Renumber current 3.2 through 3.3 as new 3.3 through 3.4.]

[Add new 3.2 as follows:]

3.2 Paper Weight

Mailpieces should be constructed from high tear strength paper stock. All references in 3.0 to paper basis weight are for book-grade paper unless otherwise stated. The conversion table in Exhibit 3.2 provides a paper basis weight cross-reference.

Exhibit 3.2 Paper Basis Weight Conversion Table

NOTE:

Paper basis weight is based on the weight of 500 sheets of:
 25 x 38 inch sheets of book-grade paper,
 17 x 22 inch bond-grade paper,
 20 x 26 inch sheets of cover-grade paper,
 24 x 36 inch sheets of newsprint.

For example, if 500 sheets of book-grade paper weigh 39 pounds, the paper is considered 39-pound book paper.

3.3 Dimensions and Shape

Each machinable or automation letter-sized piece must be rectangular (see 1.1.1) and must meet the following standards (see 3.15 for booklets):

[Add new 3.5 as follows:]

3.5 Maximum Weight, Machinable and Automation Letters and Cards

The following maximum weight limits apply:

- a. Booklets and folded self-mailers — 3 ounces.
- b. Machinable enveloped letters and cards — 3.3 ounces.
- c. Automation enveloped letters and cards — 3.5 ounces (see 3.6 for pieces over 3 ounces.)

[Renumber current 3.14.4 as new 3.6 and revise heading and text as follows:]

3.6 Heavy Letter Mail (over 3 ounces)

Heavy letter mail (letter-size pieces over 3 ounces) must be prepared in a sealed envelope, may not contain stiff enclosures, and must have an 11-digit delivery point POSTNET or an Intelligent Mail barcode with a routing code in the address block (see 202.5.0).

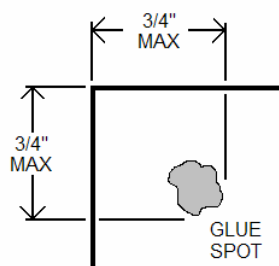
[Revise heading and text of 3.11 as follows:]

3.11 Tabs, Tape, and Glue

Tabs on booklets must be at least 1-1/2 inches in width. The tab placement standards in 3.15 are subject to 1/4-inch variance in either direction. Tabs may be made of opaque paper, translucent paper, vinyl, or plastic, and must not contain perforations. Cellophane tape may also be used as a closure. The following standards also apply:

- a. Translucent paper tabs should be made of paper with a minimum of 40-pound basis weight.
- b. Opaque paper tabs should be made of a minimum of 60-pound basis weight paper with a tear strength of at least 56 grams of force in the machine direction (MD) and 60 grams of force in the cross direction (CD).
- c. Tabs in the barcode clear zone must have a paper face meeting the standards for background reflectance and, if the barcode is not preprinted by the mailer, the standards for acceptance of water-based ink.
- d. Vinyl tabs and cellophane tape closures are not acceptable within the barcode clear zone.
- e. Tabs must be tight against the edge of the mailpiece. A maximum 1/16-inch overhang is recommended.
- f. Glue spots may be used in lieu of tabs and must be placed within 3/4 inch of the open edges (see Exhibit 201.3.11.f).

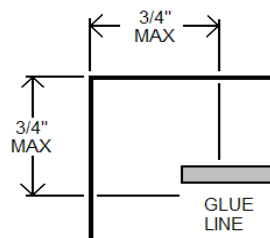
Exhibit 201.3.11.f Glue Spot Placement



- g. Continuous glue lines may be used as cover-to-cover seals and must be placed along the entire length of

the open edge and end no more than 3/4 inch from the open ends (see Exhibit 201.3.11.g).

3.14.1 General

The standards in 3.14.2 for folded self-mailers are basic requirements.

[Renumber current 3.15 as new 3.17. Renumber current 3.14.2 as new 3.15 and revise as follows:]

3.15 Booklets

3.15.1 Definition

Booklets must have a bound edge. Sheets that are fastened with at least two staples in the manufacturing fold (saddle stitched), perfect bound, pressed-glued, or joined together by another binding method that produces an end where pages are attached together are considered booklets. Booklets are open on three sides before sealing, similar in design to a book. In general, booklets must be uniformly thick. Large bound booklets that are folded for mailing qualify for automation and machinable prices if the final mailpiece remains nearly uniform in thickness.

3.15.2 Paper

Booklet covers generally must be made with a minimum paper basis weight of 60 pounds or equivalent. Minimum basis weights are higher for some designs (see 3.15.4).

3.15.3 Physical Standards for Booklets

Booklets must be:

- a. Height: not more than 6 inches or less than 3.5 inches high.
- b. Length: not more than 10.5 inches or less than 5 inches long. See Exhibit 3.15.4 for some booklet designs with shorter maximum lengths.
- c. Thickness: not more than 0.25 inch or less than 0.009 inch thick.

- d. Weight: not more than 3 ounces.
- e. Aspect ratio: within 1.3 to 2.5 (see 201.3.1).







IMM Revision: Size and Weight Limits for the Czech Republic

Effective August 3, 2009, we are revising *Mailing Standards of the United States Postal Service*, International Mail Manual (IMM[®]) in the following sections to reflect that the Czech Post has advised the Postal Service[™] to increase the size and weight limits for Express Mail International[®] and Priority Mail International[™] items sent to the Czech Republic.

IMM Revision: International Business Reply Service — Updates

Effective August 3, 2009, the Postal Service™ is revising *Mailing Standards of the United States Postal Service*, International Mail Manual (IMM®) part 382 to provide five additional options and greater ease of use for mailers who use International Business Reply Service (IBRS).

With these enhanced revisions, mailers now have the following options:

1. Mailers may now use the Intelligent Mail® barcode (previously, the Postal Service authorized only the POSTNET™ barcode).
2. Mailers may now apply the barcode in the address block of the mailpiece (previously, the Postal Service authorized the barcode only in the barcode clear zone area).
3. Mailers may now use a minimum type size of 1/8-inch high in the business reply legend (previously, the Postal Service authorized a minimum type size of 3/16-inch high).

4. Mailers may now use “INT’L BUSINESS REPLY MAIL/REPONSE PAYEE” in the business reply legend (previously, the Postal Service authorized only “INTERNATIONAL BUSINESS REPLY MAIL/REPONSE PAYEE”).

5. Mailers may now use a minimum clearance of 1/2 inch between the left edge of the mailpiece and the delivery address (previously, the Postal Service required a minimum clearance of 1 inch).

The changes to the business reply legend will assist mailers in fitting the required markings on card-size and small letter-size mailpieces.

Effective immediately, Handbook F-101, *Field Accounting Procedures*, is revised to delete section 20-1.2.1, *Repayment of Locally Adjudicated Claims*, and to discontinue the use of Account Identifier Code (AIC) 249, *Recovered Indemnity Claims*. AIC 249 will be deactivated in the reporting systems and placed on the reserve list.

The article “Handbook F-101 Revision: Claims Processing” in *Postal Bulletin 22255* (3-26-09, pages 12–15) included new policy stating that Post Offices™ and postal retail units (PRUs) no longer adjudicate claims locally. Therefore, Post Offices and PRUs must no longer accept repayments for previously paid claims or use AIC 249.

Accounting Services adjudicates all claims and processes repayments of previously paid claims.

Revised Privacy Act Notice

Effective May 2009, Notice 70, *Privacy Act Notice — Human Resources Forms*, has been revised to include the addition of two new notices.

A Privacy Act notice is required whenever an agency collects personally identifiable information (PII) about individuals and that information is retrieved by name or other personal identifier. When the Postal Service™ collects and maintains PII from other government agency forms and the information is covered under a Postal Service system of records, the Postal Service is required to provide its own Privacy Act Notice. This requirement is met by providing Notice 70 with the other agency form.

Notice 70 has been revised and is now three separate notices: one notice for each primary functional area that uses other agency forms as follows:

- Notice 70, *Privacy Act Notice — Human Resources Benefits Forms*.
- Notice 70-A, *Privacy Act Notice — Investigative and Verification Forms*.
- Notice 70-B, *Privacy Act Notice — Office of Workers' Compensation Program Forms*.

Fiscal Year 2009 Closing Guidance: Message From the Controller

2009 has been a year of unprecedented financial challenge for the Postal Service™. Many of you have undertaken extraordinary efforts to control expenses. It is vital that we carry this effort through to the end of the fiscal year by tightly controlling discretionary activity. This does not mean curtailing business, but it does mean making prudent choices by deferring or eliminating noncritical activity, and purchasing goods or services throughout the year, rather than at the end of the fiscal year simply because there are available budget funds. Please encourage your contractors to bill us in a timely manner for goods received and services rendered, so we can properly recognize the expense before the end of the fiscal year. The following instructions will assist you, when appropriate, in helping the Postal Service close its financial books in a timely and efficient manner.

I. Instructions for Fiscal Year 2009 Closing

All organizations are requested to limit their expenditures to essential spending. Accordingly, all vice presidents should review discretionary spending to ensure the Postal Service attains its financial target for this fiscal year (FY).

The instructions and reporting dates in this *Postal Bulletin* supplement procedures followed during the normal monthly or quarterly reporting schedule.

II. Fiscal Year

The Postal Service prepares its annual reports on a government FY basis, which comprises 365 days (366 in leap years), always ending on September 30.

III. End of Year Processing Activities and Timelines, Contract Modifications, and Requisitions

Capital and Expense requisitions and requests for contract modifications will not be accepted by Supply Management after September 4.

Capital purchase card transactions will be accepted by Supply Management through September 14.

Also, organizations should limit capital commitments, particularly for Postal Service support equipment, to essential needs.

The schedule for Supply Management processing is as follows:

For requisitions received...	Funds are processed as follows...
On or before September 4, 2009	Supply Management will issue the required contract or modification for Accounting Services, San Mateo to process against FY 2009 funds.
After September 4, 2009	Supply Management will issue the required contract or modification for Accounting Services, San Mateo to process against FY 2010 funds.

Hardcopy paper commitment documents must be forwarded to Accounting Services, San Mateo no later than September 18.

Electronic files must be transmitted to Accounting Services as follows:

Send electronic files for...	To...	No later than...
Contract Authoring and Management System (CAMS)	San Mateo	September 30, 2009
Facilities capital commitments and expense payments	St. Louis	September 30, 2009

Appropriate receiving reports or certified invoices for goods and services received by September 30 must be forwarded to Accounting Services, San Mateo to be received no later than October 1.

Note:

1. Expedite processing of receiving reports and certified invoices, as these documents are used to charge expense to the proper FY.
2. Additionally, review contracts to ensure sufficient funds are available by September 18 to process invoices.
3. Supply Management will process all requisitions for the issuance of contracts against FY 2009 funds according to the following priorities:
 Priority 1 — Capital commitment requisitions.
 Priority 2 — Expense commitment requisitions.

IV. Accruals

Year-end Closing:

1. Goods received and services rendered through September 30, 2009, will no longer be accrued at a field finance number level. Only invoices certified and received as indicated by the dates in Part V, Submission Schedules, below, by San Mateo by October 2, will be charged to FY 2009.

2. Headquarters ECM budget coordinators, Engineering coordinators, IT coordinators, and the Office of Inspector General (OIG) will be required to meet with Corporate Financial Reporting (CFR) to discuss amounts that need to be accrued for both capital and expense items. CFR will contact these organizations to schedule the meetings.

Thrift Savings Plan Enhancement Act of 2009

The Thrift Savings Plan (TSP) Enhancement Act of 2009, H. R. 1256, was signed into law and has a number of changes to the TSP. In particular, this law eliminates the waiting period for employees covered under the Federal Employees' Retirement System (FERS) to receive Agency Automatic (1%) and Agency Matching Contributions. These changes are effective August 1, 2009, and affect the following employees:

- (1) Newly hired or rehired FERS employees.
- (2) FERS employees who are currently employed and waiting until the second election period to become eligible for agency contributions (i.e., employees hired on or after December 1, 2008).

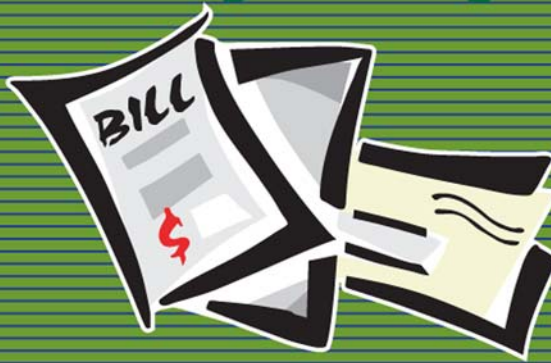
Both groups will be eligible for the Agency Automatic Contribution, and if the participant is contributing to TSP, he or she will be eligible for the associate Agency Matching Contributions.

Verifying U.S. Postal Service Money Orders

Follow these steps to cash a Postal Service™ money order:

1. Check that the amount does not exceed the legal limit: \$1,000 for domestic, and \$700 for international postal money orders.
2. Check that the proper security features are present:
 - When held to the light, a watermark of Benjamin Franklin is repeated from top to bottom on the left side.
 - When held to the light, a dark line (security thread) runs from top to bottom with the word “USPS” repeated.
 - There should be no discoloration around the dollar amounts, which might indicate the amounts were changes.

These appear in Postal Service Notice 299, *U.S. Postal Money Order Reference Card*, or online at <http://www.usps.com/missingmoneyorders/security.htm>.

3. If the money order seems suspicious, call the U.S. Postal Service Money Order Verification System at 866-459-7822.

Please provide this information to local banks and retailers, as they also receive Postal Service money orders for cashing.

Note: Mail order catalogs are prohibited as SAM or PAL mail.

A. Securities, currency, or precious metals in their raw, unmanufactured state are prohibited. Official shipments are exempt from this restriction.

A1. Mail addressed to "Any Servicemember," or similar wording such as "Any Soldier," "Sailor," "Airman," or "Marine"; "Military Mail"; etc., is prohibited. Mail must be addressed to an individual or job title such as "Commander," "Commanding Officer," etc.

B. PS Form 2976-A is required for all mail weighing 16 ounces or more, with exceptions noted below. In addition, mailers must properly complete required customs documentation when mailing any potentially dutiable mail addressed to an APO, FPO, or DPO regardless of weight. The following are exceptions to the requirement for customs documentation on nondutiable mail that weighs 16 ounces or more:

- Known mailers are exempt from providing customs documentation on non-dutiable letters, and printed matter weighing 16 ounces or more. (A known mailer is anyone who legally applies a permit imprint to a mailpiece. Mail with meter postage is not considered to be from a known mailer.)
- All federal, state, and local government agencies are exempt from providing customs documentation on mail addressed to an APO, FPO, or DPO except for those APOs/FPOs/DPOs to which restriction B2 applies.
- Prepaid mail from military contractors is exempt, providing the mailpiece is endorsed "Contents for Official Use — Exempt from Customs Requirements."

B1. PS Form 2976 or 2976-A is required. Articles are liable for customs duty and/or purchase tax unless they are bona fide gifts intended for use by military personnel or their dependents. When the contents of a parcel meet these requirements, the mailer must endorse the customs form, "Certified to be a bona fide gift, personal effects, or items for personal use of military personnel and dependents," under the heading, Description of Contents.

Exceptions: All other exceptions listed in restriction B above are applicable to this restriction.

B2. All federal, state, and local government agencies must complete customs documentation when sending mail addressed to or from this APO, FPO, or DPO weighing 16 ounces or more.

C. Cigarettes and other tobacco products are prohibited.

C1. Obscene articles, prints, paintings, cards, films, videotapes, etc., and horror comics and matrices are prohibited.

D. Coffee is prohibited.

E1. Medicines or vaccines not conforming to French laws are prohibited.

E2. Any matter depicting nude or seminude persons, pornographic or sexual items, or nonauthorized political materials is prohibited. Although religious materials contrary to the Islamic faith are prohibited in bulk quantities, items for the personal use of the addressee are permissible.

E3. Radio transceivers, cordless telephones, global positioning systems, scanners, base stations, and handheld transmitters are prohibited.

F. Firearms of any type are prohibited in all classes of mail. See definitions of firearms in DMM 601.11.1.c. This restriction does not apply to firearms mailed to or by official U.S. government agencies. The restriction for mail to this APO/FPO/DPO ZIP Code does not apply to firearms mailed from this APO/FPO/DPO ZIP Code, provided ATF and USPS regulations are met. Antique firearms are a separate category defined in DMM 601.11.2 and ATF regulations; they do not require an ATF form.

F1. Privately owned weapons addressed to an individual are prohibited in any class of mail.

F2. Importation of firearms is restricted to one shotgun and one single shot.22 caliber rifle per individual.

G. Only letters, flats, and Periodicals are authorized. Parcels of any class are prohibited.

H. Meats, including preserved meats, whether hermetically sealed or not, are prohibited.

H1. Pork or pork by-products are prohibited.

I. Mail of all classes must fit in a mail sack. Mail may not exceed the following dimensions:

- Maximum length 20 inches.
- Maximum width 12 inches.
- Maximum height 12 inches.

The maximum length and girth combined may not exceed 68 inches.

This restriction does not apply to registered mail and official government mail marked MOM.

I1. This restriction does not apply to registered mail.

I2. This restriction does not apply to official government mail marked MOM.

J. Parcels may not exceed 108 inches in length and girth combined.

K. Mail that includes in the address the words, "Dependent Mail Section," may consist only of letter mail, newspapers, magazines, and books. No parcel of any class containing any other matter may be mailed to the Dependent Mail section. This restriction does not apply if the address does not include the words "Dependent Mail Section."

L. All official mail is prohibited.

M. Fruits, vegetables, animals, and living plants are prohibited.

N. Registered mail is prohibited.

O. Delivery status information for Extra Services is not available on USPS.com.

P. APO is used for the receipt and dispatch of official mail only.

Q. Mail may not exceed 66 pounds, and size is limited to 42 inches maximum length and 72 inches maximum length and girth combined.

R. All alcoholic beverages, including those mailable under DMM 601.11.7, are prohibited.

R1. Materials used in the production of alcoholic beverages (i.e., distilling material, hops, malts, yeast, etc.) are prohibited.

T. Mailings of case lots of food and supplemental household shipments must be approved by the sender's parent agency prior to mailing.

U. Parcels must weigh less than 16 ounces when addressed to Box R. This restriction does not apply to mail endorsed "Free Matter for the Blind or Handicapped."

U1. Mail is limited to First-Class Mail weighing 13 ounces or less when addressed to Box R. This restriction does not apply to mail endorsed "Free Matter for the Blind or Handicapped." Videotapes are prohibited when addressed to Box R, regardless of weight.

U2. Mail is limited to First-Class Mail letters only when addressed to Box R.

U3. Mail is limited to First-Class Mail correspondence (including voice and video cassettes), newspapers, magazines, photographs, not exceeding 16 ounces, when addressed to Box R.

V. Express Mail Military Service (EMMS) not available from any origin.

V1. Delivery Confirmation service is not available.

W. Meat products, such as dried beef, salami, and sausage, may be mailed, provided they remain in their original, hermetically sealed packages and bear USDA certification. Other meats, bones, skin, hair, feathers, horns or hoofs of hoofed animals, wool samples, tobacco leaves, including chewing and pipe tobacco, snuff, cigars, and cigarettes, or obscene material, including obscene drawings, photographs, films, and carvings, are prohibited. Exception: 200 grams of tobacco per parcel are permitted duty free.

X. Personal mail is limited to First-Class Mail items (to include audio cassettes and voice tapes) weighing 13 ounces or less. This limitation does not apply to official mail.

Y. Mail is limited to First-Class and Priority Mail items only. All Periodicals, Standard Mail items, and Package Services items (including SAM and PAL) are not authorized. This restriction also applies to official mail.

Z. No outside pieces (OSPs).

Z1. The following restriction is applicable only to International Service Centers (ISC)/Exchange Offices. An Anti-Pilferage Seal (Item No O817E or O818A) is required on all pouches and sacks.

Stamp distribution offices (SDOs) will receive approximately 40–45 percent of their standard automatic distribution quantity for a PSA sheet stamp. Distributions are rounded up to the nearest master carton size of 40,000 stamps.

Initial Supply to Post Offices

SDOs will make a subsequent automatic distribution to Post Offices of 25 percent of their standard automatic distribution quantity using PS Form 17, *Stamp Requisition/Stamp Return*. SDOs must not distribute this commemorative sheet to Post Offices before September 2, 2009.

Additional Supply

Post Offices requiring additional stamps must requisition them from their designated SDO using PS Form 17. SDOs requiring additional stamps must order them from the appropriate accountable paper depository (APD) using PS Form 17.

For fulfilling supplemental orders from SDOs, the San Francisco, Memphis, New York, and Chicago APDs will receive additional stamps.

Sales Policy

All Post Offices must acquire and maintain a supply of each new commemorative stamp as long as customer demand exists, until inventory is depleted, or until the stamp is officially withdrawn from sale. If supplies run low, Post Offices must reorder additional stamps using their normal ordering procedures.

Pictorial Postmarks Announcement

As a community service, the Postal Service™ offers pictorial postmarks to commemorate local events celebrated in communities throughout the nation. A list of events for which pictorial postmarks are authorized appears below. The sponsor of the pictorial postmark appears in italics under the date. Also provided are illustrations of these postmarks.

People attending these local events may obtain the postmark in person at the temporary Post Office™ station established there. Those who cannot attend the event but who wish to obtain the postmark may submit a mail order request. Pictorial postmarks are available only for the dates indicated, and *requests must be postmarked no later than 30 days following the requested pictorial postmark date.*

All requests must include a stamped envelope or postcard bearing at least the minimum First-Class Mail® post-

age. Items submitted for postmark may not include postage issued after the date of the requested postmark. Such items will be returned unserved.

Customers wishing to obtain a postmark should affix stamps to any envelope or postcard of their choice, address the envelope or postcard to themselves or others, insert a card of postcard thickness in envelopes for sturdiness, and tuck in the flap. Place the envelope or postcard in a larger envelope and address it to: PICTORIAL POSTMARKS, followed by the NAME OF THE STATION, ADDRESS, CITY, STATE, ZIP+4® CODE, as listed below.

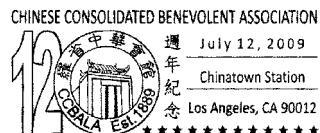

How to Order the First Day of Issue Digital Color or Traditional Postmarks

Customers have 60 days to obtain the first day of issue postmarks by mail. They may purchase new stamps at their local Post Office™, by telephone at 800-STAMP-24, or at The Postal Store® website at www.usps.com/shop.

Traditional Postmarks

Customers should affix the stamps to envelopes of their choice, address them to themselves or others, or provide a self-addressed return envelope with sufficient postage large enough to accommodate the canceled item. Mail the request to the corresponding city of issuance. There is no charge for the first 50 postmarks. There is a 5-cent charge for each additional postmark over 50. Customers should submit a check, money order, or credit card for payment. After applying the first day of issue postmark, the Postal Service™ will return the envelopes to the customer by U.S. Mail.

All postmark requests should go to the first day of issue city. The first day of issue city Post Office will then forward in bulk all postmark requests to Cancellation Services, Stamp Fulfillment Services, PO Box 449992, Kansas City, MO 64144-9992 by respective Post Offices.

Digital Color Postmarks

Only select stamp issues offer a digital color postmark. Customers may submit #6 or #10 envelopes constructed of paper rated as "laser safe." The Postal Service recommends envelopes of 80-pound Accent Opaque, acid-free, 9/16" side seams with no glue on the flap. The maximum

size of all digital color postmarks is 2" high x 4" long. Allow sufficient space on the envelope to accommodate the postmark. Do not use self-adhesive labels for addresses on the envelope. Two test envelopes must be included. There is a minimum of 10 envelopes at 50 cents per postmark required at the time of servicing. Customers should submit a check, money order, or credit card for payment.

The Postal Service reserves the right to not accept hand-painted and other cachet envelopes that are not compatible with our digital color postmark equipment. The Postal Service also reserves the right to substitute traditional black rubber postmarks if use of nonspecified envelopes results in poor image quality or damage to equipment.

Customers should affix the stamps to the envelopes and address them to themselves or others for return through the mail. Or, they may include an additional self-addressed return envelope, large enough to accommodate their canceled items, with sufficient postage affixed for return of their postmarked items. Mail the request for a first day of issue digital color postmark to the corresponding city of issuance. Post Offices will then forward all customer requests for digital color postmarks to Cancellation Services, Stamp Fulfillment Services, PO Box 449992, Kansas City, MO 64144-9992.

After applying the first day of issue postmark, the Postal Service will return the envelopes to the customer by U.S. Mail.

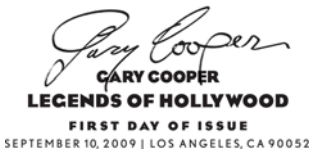

Custodial Products — Buy From National Contracts not General Services Administration

USPS® facilities across the country have taken great strides in utilizing the two national contracts for custodial products and supplies, Cleanwise and W. W. Grainger. In compliance with the letter from CFO, Joseph Corbett, both suppliers have shown an even greater commitment in the price reduction of custodial items, by providing USPS the most favorable pricing possible. MLB-CO-01-012 specifies that these two national contracts are a “priority source of supply for all postal locations and must be used for the purchase of custodial products”. However, many facilities are ordering custodial products through eMARS from the General Services Administration (GSA). These same items may be acquired through eMARS from Cleanwise and/or W. W. Grainger at a lesser cost. The listing of high volume

items below shows the GSA original national stock number (NSN) and the Cleanwise/W. W. Grainger equivalent eBuy catalog item number.

Note: Effective immediately, future requests submitted through eMARS for these custodial items will no longer be available from GSA, but must be purchased from one of the national suppliers. If additional information is needed, you may contact the Environmental/ Maintenance Repair and Operations (MRO) Category Management Center (CMC) at 214-819-7109 or Pat Chumney at 214-819-7105. Your assistance in the transition of the purchase of these items from GSA to one of our national custodial products’ suppliers is greatly appreciated and will save the Postal Service money.

New Requirement for Custodial Rental Items Contracts Effective October 1, 2009

Facilities receiving custodial rental items from Cintas or UniFirst must submit a new, on-catalog requisition through eBuy to reflect the new pricing for their requirements, effective October 1, 2009. Previously funded requisitions will remain active in eBuy until all invoices created under the old price structure are paid and the new price structure is implemented. In order for the suppliers to submit invoices reflecting the updated pricing and receive payment, a new requisition must be in the eBuy system prior to September 30, 2009. Payment cannot be made from the existing requisition with obsolete pricing after this date.

New items added to both custodial rental contracts include ladies' executive pants and shirts and a variety of wet and dry microfiber mops. On-catalog eBuy orders for the new items and updated pricing must be completed between August 1, 2009, and September 30, 2009.

Minimum Wage Change

Effective July 24, 2009, the federally mandated minimum wage was increased to \$7.25 per hour. Local buying officials must ensure that self-employed service suppliers, who supply services purchased under local buying procedures, earn no less than the minimum wage of \$7.25 per hour as of July 24, 2009. The Semi-annual Capital Property Reviews are a Sarbanes-Oxley (SOX) requirement. A list of finance numbers that receive a Semi-Annual Capital Property Certification Report but do not submit the report on time will be escalated for further action.

The district material management specialists (DMMSs) will provide instructions and guidelines on how their districts should conduct the Semi-annual Capital Property Reviews; the Material Service Centers (MSCs) will provide similar support for the Headquarters groups. Handbook AS-701, *Material Management*, is under revision; instructions and guidelines provided by the DMMSs and MSCs will supersede Handbook AS-701 where there are conflicts.
