DMM Revision: New Content Identification Number Codes for Use With Priority Mail Open and Distribute Shipments

Effective May 7, 2012, the Postal Service™ will revise *Mailing Standards of the United States Postal Service*, Domestic Mail Manual (DMM®) 705.18 and Exhibit 708.6.2.4 to provide an expanded choice of content identification number (CIN) codes for use with Priority Mail Open and Distribute® (PMOD) shipments.

PMOD provides a cost-effective alternative for mailers who want to expedite mailings of other classes of mail to destination postal facilities, and is a means to attain eligibility for destination entry prices for the applicable classes and shapes of mail. When using PMOD, mailers prepare the mailings according to standards for the enclosed class of mail, enclose the mail in containers for expedited service as PMOD, and present the mailings to a postal acceptance unit by the critical entry time for USPS® dispatch.

The expansion of CIN code options will allow USPS routing systems to recognize the PMOD container as an expedited product, and also the applicable entry-level, mail class, and/or shape of the contents. Use of these new CIN code options will also allow PMOD tray or sack labels to be scanned by “Scan Where You Band” (SWYB) equipment, enabling the generation of dispatch and routing labels (D&R tag) for routing and distribution to the USPS air networks.

As a result of the improved scanning processes made possible by the use of barcoded tray and sack labels, these new CIN codes will result in increased visibility of PMOD shipments through to each of their intended destinations. When a barcoded PMOD barcode is scanned, along with its accompanying barcoded tray or sack label, the barcode is associated with a specific D&R tag, providing unique visibility for the PMOD container and its contents within USPS internal networks. Once a tray or sack label is associated with a D&R tag, the container and its contents can be associated with any subsequent D&R tag scan events through to its destination. USPS Operations is also exploring similar visibility solutions for its surface network.

To increase network and processing operational efficiencies, the Postal Service will be adding new CIN codes that more accurately describe the contents of several of the most commonly used applications for PMOD shipments. In accordance with DMM 705.18.5.2, trays and sacks used with PMOD shipments must include the appropriate CIN code. Mailers must also use the CIN code that best describes the class and/or processing category of the con-

tents of the shipment and its destination-entry level. When no specific CIN code can accurately describe the contents of the PMOD container, the “165” generic CIN code must be used.

In order to allow adequate time for mailers to make the appropriate changes to their systems, the Postal Service will provide a transitional period from the online publication date of the DMM that includes this revision. Therefore, mailers may continue to use the current “165” CIN codes with their PMOD shipments until June 24, 2012.

The Postal Service is revising portions of 705.18.5.2 and 18.5.6 to clarify that, in addition to Express Mail open and distribute (EMOD) and PMOD shipments enclosed in sacks, shipments enclosed in tray boxes and similar containers must also bear barcoded tray labels. It was the intent of the Postal Service, when providing the new tray box options, to process and transport these shipments similarly to shipments enclosed in sacks. The Postal Service will be providing tray label holders (USPS item 09330) with all future requests for EMOD and PMOD tray boxes and similar USPS-provided containers. Mailers may continue to use their current inventory of tray boxes and similar containers without including tray labels, but must affix tray labels to their EMOD and PMOD containers once tray label holders are provided. Effective June 24, 2012, mailers must affix tray labels, including an accurate CIN code, to all EMOD and PMOD tray boxes and similar containers. Although mailers may affix the tray label holders on either end of a tray box, or similar container, to the right of the hand-hold cutout, the Postal Service recommends that the tray label holder be placed on the end of the tray box nearest to the EMOD or PMOD address label.

Mailers without the ability to print their own tray labels may obtain tray labels from the USPS Customer Label Distribution System (CLDS). CLDS allows mailers to create, edit, and submit for printing their own Intelligent Mail® tray label orders online. Mailers will first need to register within the CLDS system to receive sign-in information. To obtain more information go to <https://clds.usps.com/CLDS/>.

The Postal Service will also remove an obsolete reference to the provision to allow Delivery Confirmation™ not flat-machinable (NFM) items in PMOD shipments. The NFM product category has been eliminated.

These changes will be reflected in the May 7, 2012, online DMM update, but mailers may begin using these new CIN codes with their PMOD shipments immediately.

Labels for Express Mail Open and Distribute trays, sacks, and similar containers must be barcoded and meet the requirements in 708.6.0. Tray boxes, sacks, and other containers (except pallets and pallet boxes) used for Priority Mail Open and Distribute shipments must bear a barcoded tray or sack label that includes the appropriate CIN code that best describes the class and processing category of the contents of the shipment. When no specific CIN code accurately describes all of these elements, the “165” generic code must be used. It is recommended that all EMOD and PMOD shipments bear Intelligent Mail tray barcodes prepared under 708.6.5. Although mailers may affix

tray labels on either end of a tray box (or similar container), to the right of the hand-hold cutout, the recommended placement is on the end of the tray box nearest to the EMOD or PMOD address label. All lines of information must be completely visible when inserted into the label holder. Label trays or sacks as follows:

IMM Revision: Priority Mail International Insurance Updates to Cameroon, Lebanon, and Montenegro

Effective May 7, 2012, the Postal Service™ will revise *Mailing Standards of the United States Postal Service, International Mail Manual (IMM®)* to reflect the availability of insurance for Priority Mail International® parcel service to the following countries:

- Cameroon has eliminated the option to purchase insurance for Priority Mail International parcel items. (Previously, the maximum limit was \$5,000.) Consequently, the option to purchase return receipt service for insured Priority Mail International parcels is also eliminated.
- Lebanon has eliminated the option to purchase insurance for Priority Mail International parcel items. (Previously, the maximum limit was \$65.) Consequently, the option to purchase return receipt service for insured Priority Mail International parcels is also eliminated.
- Montenegro offers the option to purchase insurance for Priority Mail International parcel items up to a maximum limit of \$5,000. (Previously, insurance for Priority Mail International parcels was not available.)

Publication 75, Mover's Guide, News

The April 2012 issue of Publication 75, *Mover's Guide*, is in process of being shipped to all Post Office™ facilities. All shipments should be received by March 31, 2012. As of April 1, 2012, recycle all expired versions.

Mover's Guide News

Beginning with this April 2012 shipment, the total quantity of *Mover's Guide* copies sent to your facility may have been reduced. In an effort to reduce waste and account for more customers submitting change-of-address orders online, fewer *Mover's Guide* copies are needed. There are several things you can do to conserve as well:

- Make sure customers are aware that *USPS.com*® is the most convenient, safe, and secure way for customers to submit a change-of-address order.
- Encourage carriers to carry ICOA Message Cards on their routes instead of *Mover's Guide* copies.
- Give *Mover's Guide* copies out to moving customers only.

The *Mover's Guide* shipments now include Intelligent Mail Package Barcodes (IMpb). Please scan these codes per standard procedure upon shipment arrival.

The cover of the *Mover's Guide* envelope includes color-coded up/down arrows along with the in-market dates to convey its effective quarter. The corresponding color code of the up/down arrow for the April 2012 issue is green.

Mover's Guide Information

- Offices will receive copies of *Mover's Guide* in one or two shipments. The first shipments will arrive at the end of March. The second shipments will arrive 3 to

5 weeks later. Shipments are sent in quantities of 25, 100, and 300.

- Your facility may receive copies of *Mover's Guide* addressed to other offices that must be distributed to their respective offices. Break down each pallet in accordance with the posted plaque, check the labels, and forward the guides as appropriate.

Behind the Counter Program

Below are a few points about program compliance:

- Effective immediately, sales and service associates may no longer distribute more than three copies of *Mover's Guide* per customer. Instruct customers who need more than three copies to change their additional address(es) online at www.usps.com.
- Copies of *Mover's Guide* must be kept behind the counter. No copies of *Mover's Guide* should be placed in the inner or outer lobby or on the clerk counters. *If you have copies of the Mover's Guide in the lobby at this time, remove them and place them behind the counter.*
- When customers approach the counter requesting change-of-address materials, retail associates should first encourage their customers to go online at www.usps.com. Internet change of address (ICOA) transactions provide customers with the most convenient, safe, and secure way to change their address.
- Customers unwilling or unable to submit their change of address at www.usps.com should be given a complete, unopened copy of *Mover's Guide*. The envelope contains instructions and valuable offers that generate revenue for the Postal Service™. When you

throw out the envelope and its contents, the Postal Service loses money.

Note: The Mover's Guide Behind the Counter Program is part of the ad-hoc section of the 2010 Retail Customer Experience Program, so it is critical that your Post Office be compliant with the program throughout the year by keeping copies of *Mover's Guide* out of Post Office lobbies.

ICOA Message Card Information

- If your Post Office has an ICOA Message Card display, *do not throw it away*. The display is *required* to be in the lobby and expected to have the ICOA Message Cards in it at all times. Replenishment cards and updated banners are mailed with your *Mover's Guide* shipments.
- If your Post Office *does not* have an ICOA Message Card display, you must call the replenishment phone number below for ICOA Message Card replenishment.
- If any Post Office runs out of ICOA Message Cards between shipments, call Imagitas at 800-816-6837,

or visit our website at <http://imagitas.com/contact/postal-request-form/> for replenishment.

- All Post Offices must have ICOA Message Cards in their lobbies for customer reference.

This placard should be especially useful to postage due units.

Mobile Commerce and Personalization Promotion

On February 21, 2012, the Postal Service™ filed a Notice of Price Adjustment with the Postal Regulatory Commission (PRC) for a 2012 Mobile Commerce and Personalization Promotion tentatively scheduled to run July–August 2012, with registration beginning May 1, 2012. Implementation of the program is subject to PRC approval.

The intent of the 2012 promotion is to build on the success of the 2011 Mobile Barcode Promotion. The 2011 promotion was successful in generating awareness of how mobile technology could be integrated with direct mail. The Postal Service now wants to continue to create awareness of more innovative uses of mobile barcodes and encourage mailers to adopt “best practices” associated with these technologies.

Pending approval by the PRC, the 2012 Mobile Commerce and Personalization Promotion will provide business mailers with an upfront 2 percent postage discount on Standard Mail® and First-Class Mail® letters, flats, and cards (presort and automation only) that include a two-dimensional (2-D) barcode or print/mobile technology that

can be read or scanned by a mobile device. The 2012 promotion will specify that the barcode or similar technology must lead the recipient to either: (1) a webpage that allows the recipient to purchase a product or service on a mobile device, or (2) a personalized URL, which leads to a webpage that is unique to an individual recipient. Best practices such as directional copy and mobile optimization are also required.

The form has been revised multiple times and “Distribution: Copy 3 — HQ” has not been a part of the application for several years, but we continue to get copies of the application. Many offices continue to use the 2005 or 2006 edition of the form, and others are making copies of “Distribution: Copy 1 — Post Office” and sending it to HQ.

Please use the most current, January 2011, edition of the form. It has a new format and the Terms and Conditions have been updated. You can order the current edition of the form from the Material Distribution Center and use touch-tone order entry (TTOE). Call 800-273-1509.

Note: You must be registered to use TTOE. To register, call 800-332-0317, option 1, extension 2925, and follow the prompts to leave a message. (Wait 48 hours after registering before placing your first order.)

Verifying U.S. Postal Service Money Orders

Follow these steps to cash a Postal Service™ money order:

1. Check that the amount does not exceed the legal limit: \$1,000 for domestic, and \$700 for international postal money orders.
2. Check that the proper security features are present:
 - When held to the light, a watermark of Benjamin Franklin is repeated from top to bottom on the left side.
 - When held to the light, a dark line (security thread) runs from top to bottom with the word “USPS” repeated.
 - There should be no discoloration around the dollar amounts, which might indicate the amounts were changes.

3. If the money order seems suspicious, call the U.S. Postal Service Money Order Verification System at 866-459-7822.

A. Securities, currency, or precious metals in their raw, unmanufactured state are prohibited. Official shipments are exempt from this restriction.

A1. Mail addressed to "Any Servicemember," or similar wording such as "Any Soldier," "Sailor," "Airman," or "Marine"; "Military Mail"; etc., is prohibited. Mail must be addressed to an individual or job title such as "Commander," "Commanding Officer," etc.

B. Regardless of mail class, a customs declaration form is required for all items weighing 16 ounces or more, or any item (regardless of weight) containing potentially dutiable mail contents (e.g., merchandise) addressed to an APO, FPO, or DPO ZIP Code. PS Form 2976 is required for items weighing less than 16 ounces, and PS Form 2976-A is required for items weighing 16 ounces or more. No customs form is required for items weighing less than 16 ounces when the contents are not potentially dutiable (e.g., documents). When the surface area of the address side of the mailpiece is not large enough to contain a PS Form 2976-A, the smaller PS Form 2976 may be substituted (e.g., the Priority Mail Small Flat Rate Box). The following exceptions apply:

- Known mailers are exempt from providing customs documentation on non-dutiable letters or printed matter. (A known mailer is a business mailer who enters volume mailings through a business mail entry unit (BMEU) or other bulk mail acceptance location, pays postage through an advance deposit account, uses a permit imprint for postage payment, and submits a completed postage statement at the time of entry that certifies that the mailpieces contain no dangerous materials that are prohibited by postal regulations.)
- All federal, state, and local government agencies whose mailings are regarded as "Official Mail" are exempt from providing customs documentation on any item addressed to an APO, FPO, or DPO except for those APOs/FPOs/DPOs to which restriction "B2" applies.
- Prepaid mail from military contractors is exempt, providing the mailpiece is endorsed "Contents for Official Use — Exempt from Customs Requirements."

B2. All federal, state, and local government agencies must complete customs documentation when sending potentially dutiable mail addressed to or from this APO, FPO, or DPO.

C. Cigarettes and other tobacco products are prohibited.

C1. Obscene articles, prints, paintings, cards, films, videotapes, etc., and horror comics and matrices are prohibited.

D. Coffee is prohibited.

E1. Medicines or vaccines not conforming to French laws are prohibited.

E2. Any matter depicting nude or seminude persons, pornographic or sexual items, or nonauthorized political materials is prohibited. Although religious materials contrary to the Islamic faith are prohibited in bulk quantities, items for the personal use of the addressee are permissible.

E3. Radio transceivers, cordless telephones, global positioning systems, scanners, base stations, and handheld transmitters are prohibited.

F. Firearms of any type are prohibited in all classes of mail. See definitions of firearms in DMM 601.11.1.1c. This restriction does not apply to firearms mailed to or by official U.S. government agencies. The restriction for mail to this APO/FPO/DPO ZIP Code does not apply to firearms mailed from this APO/FPO/DPO ZIP Code, provided ATF and USPS regulations are met. Antique firearms are a separate category defined in DMM 601.11.2 and ATF regulations; they do not require an ATF form.

F1. Privately owned weapons addressed to an individual are prohibited in any class of mail.

F2. Importation of firearms is restricted to one shotgun and one single shot.22 caliber rifle per individual.

G. Only letters, flats, and Periodicals are authorized. Parcels of any class are prohibited.

H. Meats, including preserved meats, whether hermetically sealed or not, are prohibited.

H1. Pork or pork by-products are prohibited.

I. Mail of all classes must fit in a mail sack. Mail may not exceed the following dimensions:

- Maximum length 20 inches.
- Maximum width 12 inches.
- Maximum height 12 inches.

The maximum length and girth combined may not exceed 68 inches.

This restriction does not apply to registered mail and official government mail marked MOM.

I1. This restriction does not apply to registered mail.

I2. This restriction does not apply to official government mail marked MOM.

J. Parcels may not exceed 108 inches in length and girth combined.

K. Mail that includes in the address the words, "Dependent Mail Section," may consist only of letter mail, newspapers, magazines, and books. No parcel of any class containing any other matter may be mailed to the Dependent Mail section. This restriction does not apply if the address does not include the words "Dependent Mail Section."

L. All official mail is prohibited.

M. Fruits, vegetables, animals, and living plants are prohibited.

N. Registered mail is prohibited.

O. Delivery status information for Extra Services is not available on USPS.com.

P. APO is used for the receipt and dispatch of official mail only.

Q. Mail may not exceed 66 pounds, and size is limited to 42 inches maximum length and 72 inches maximum length and girth combined.

R. All alcoholic beverages, including those mailable under DMM 601.11.7, are prohibited.

R1. Materials used in the production of alcoholic beverages (i.e., distilling material, hops, malts, yeast, etc.) are prohibited.

S. Mail of all classes must fit in a mail sack. Mail may not exceed the following dimensions and weight:

- Maximum length 12 inches.
- Maximum width 12 inches.
- Maximum height 5 1/2 inches.
- Maximum weight 25 pounds.

The maximum length and girth combined may not exceed 47 inches.

T. Mailings of case lots of food and supplemental household shipments must be approved by the sender's parent agency prior to mailing.

U. Parcels must weigh less than 16 ounces when addressed to Box R. This restriction does not apply to mail endorsed "Free Matter for the Blind or Handicapped."

U1. Mail is limited to First-Class Mail weighing 13 ounces or less when addressed to Box R. This restriction does not apply to mail endorsed "Free Matter for the Blind or Handicapped." Videotapes are prohibited when addressed to Box R, regardless of weight.

U2. Mail is limited to First-Class Mail letters only when addressed to Box R.

U3. Mail is limited to First-Class Mail correspondence (including voice and video cassettes), newspapers, magazines, photographs, not exceeding 16 ounces, when addressed to Box R.

U4. Mail addressed to Box C is limited to 2 pounds, regardless of class.

V. Express Mail Military Service (EMMS) not available from any origin.

V1. Delivery Confirmation service is not available.

W. Meat products, such as dried beef, salami, and sausage, may be mailed, provided they remain in their original, hermetically sealed packages and bear USDA certification. Other meats, bones, skin, hair, feathers, horns or hoofs of hoofed animals, wool samples, tobacco leaves, including chewing and pipe tobacco, snuff, cigars, and cigarettes, or obscene material, including obscene drawings, photographs, films, and carvings, are prohibited. Exception: 200 grams of tobacco per parcel are permitted duty free.

X. Personal mail is limited to First-Class Mail items (to include audio cassettes and voice tapes) weighing 13 ounces or less. This limitation does not apply to official mail.

Y. Mail is limited to First-Class and Priority Mail items only. All Periodicals, Standard Mail items, and Package Services items (including SAM and PAL) are not authorized. This restriction also applies to official mail.

Z. No outside pieces (OSPs).

Z1. The following restriction is applicable only to International Service Centers (ISC)/Exchange Offices. An Anti-Pilferage Seal (Item No O817E or O818A) is required on all pouches and sacks.

The G Fund is managed internally by the Federal Retirement Thrift Investment Board. Assets of the F, C, S, and I Funds are managed externally. The Board currently has contracts with BlackRock Institutional Trust Company, N.A., to manage the F, C, S, and I Fund assets. The F, C, S, and I Funds invest in commingled trust funds, in which the assets of tax-deferred employee benefit plans are combined and invested together. The F, C, S, and I Funds and the BlackRock funds are passively managed index funds.

Future performance of the funds will vary and may be significantly different from the returns shown above. See the *Summary of the Thrift Savings Plan* for detailed information about the funds and their investment risks. The monthly returns of the TSP Funds represent net earnings for the month after deduction of accrued administrative expenses and, except for the G Fund, after deduction of trading costs and accrued investment management fees as well. The returns for the four indexes shown do not include any of these deductions.

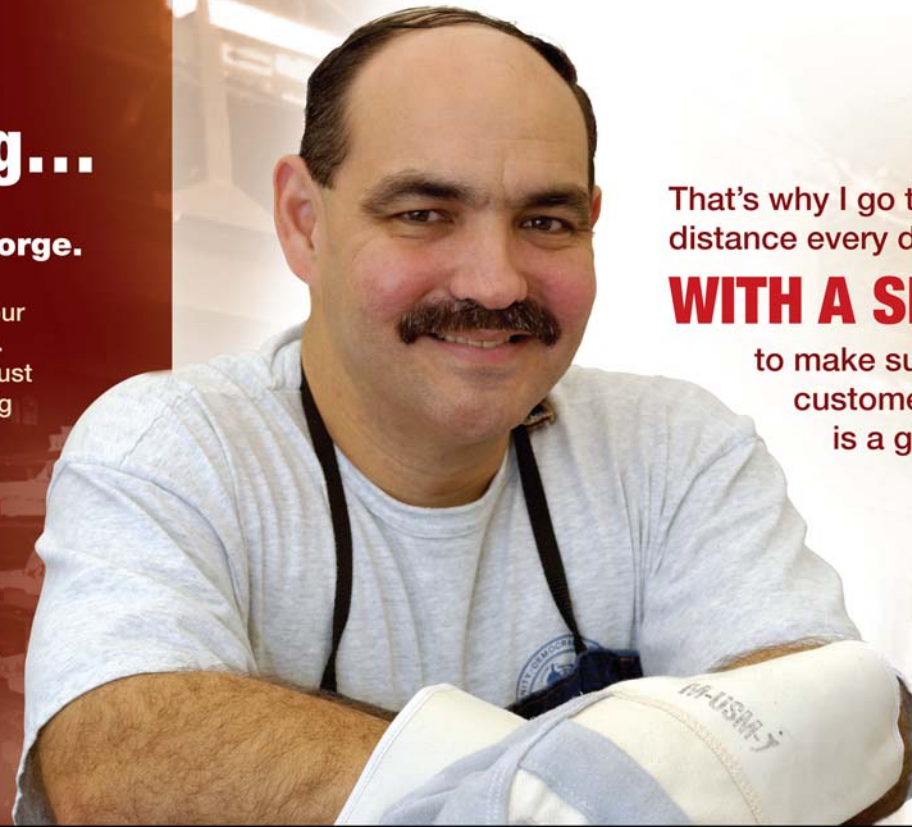

Stamp Announcement 12-26: The Civil War: 1862

On April 24, 2012, in New Orleans, Louisiana, the Postal Service™ will issue *The Civil War: 1862* (Forever® priced at 45 cents) commemorative se-tenant pair (two designs) in a pressure-sensitive adhesive (PSA) souvenir sheet of 12 stamps (Item 577000). **The \$5.40 *The Civil War: 1862* souvenir sheet may not be split, and the stamps may not be sold individually.**

The stamp will go on sale nationwide April 24, 2012.

With this 2012 issuance, the U.S. Postal Service® continues its series commemorating the 150th anniversary of the Civil War, joining others across the country in paying tribute to the American experience during the tumultuous years from 1861 to 1865. A souvenir sheet of two stamps is being issued each year through 2015. For 2012, one stamp depicts the Battle of New Orleans, the first significant achievement of the U.S. Navy in the war, while the other depicts the Battle of Antietam, which marked the bloodiest day of the war and a major turning point. Pictorial Postmarks Announcement

As a community service, the Postal Service™ offers pictorial postmarks to commemorate local events celebrated in communities throughout the nation. A list of events for which pictorial postmarks are authorized appears below. The sponsor of the pictorial postmark appears in *italics* under the date. Also provided are illustrations of these postmarks.

People attending these local events may obtain the postmark in person at the temporary Post Office™ station established there. Those who cannot attend the event but who wish to obtain the postmark may submit a mail order request. Pictorial postmarks are available only for the dates indicated, and *requests must be postmarked no later than 30 days following the requested pictorial postmark date.*

All requests must include a stamped envelope or postcard bearing at least the minimum First-Class Mail® postage. Items submitted for postmark may not include

postage issued after the date of the requested postmark. Such items will be returned unserved.

Customers wishing to obtain a postmark should affix stamps to any envelope or postcard of their choice, address the envelope or postcard to themselves or others, insert a card of postcard thickness in envelopes for sturdiness, and tuck in the flap. Place the envelope or postcard in a larger envelope and address it to: Pictorial Postmarks, followed by the Name of the Station, Address, City, State, ZIP+4® Code, as listed below.

Customers can also send stamped envelopes and postcards without addresses for postmark, as long as they supply a larger envelope with adequate postage and their return address. How to Order the First Day of Issue Digital Color or Traditional Postmarks

Customers have 60 days to obtain the first day of issue postmarks by mail. They may purchase new stamps at their local Post Office™, by telephone at 800-STAMP-24, or at The Postal Store® website at www.usps.com/shop.

Traditional Postmarks

Customers should affix the stamps to envelopes of their choice, address them to themselves or others, or provide a self-addressed return envelope with sufficient postage large enough to accommodate the canceled item. Mail the request to the corresponding city of issuance. There is no charge for the first 50 postmarks. There is a 5-cent charge for each additional postmark over 50. Customers should submit a check, money order, or credit card for payment. After applying the first day of issue postmark, the Postal Service™ will return the envelopes to the customer by U.S. Mail.

All postmark requests should go to the first day of issue city. The first day of issue city Post Office will then forward in bulk all postmark requests to Cancellation Services, Stamp Fulfillment Services, PO Box 449992, Kansas City, MO 64144-9992 by respective Post Offices.

Digital Color Postmarks

Only select stamp issues offer a digital color postmark. Customers may submit #6 or #10 envelopes constructed of paper rated as "laser safe." The Postal Service recommends envelopes of 80-pound Accent Opaque, acid-free, 9/16" side seams with no glue on the flap. The maximum

size of all digital color postmarks is 2" high x 4" long. Allow sufficient space on the envelope to accommodate the postmark. Do not use self-adhesive labels for addresses on the envelope. Two test envelopes must be included. There is a minimum of 10 envelopes at 50 cents per postmark required at the time of servicing. Customers should submit a check, money order, or credit card for payment.

The Postal Service reserves the right to not accept hand-painted and other cachet envelopes that are not compatible with our digital color postmark equipment. The Postal Service also reserves the right to substitute traditional black rubber postmarks if use of nonspecified envelopes results in poor image quality or damage to equipment.

Customers should affix the stamps to the envelopes and address them to themselves or others for return through the mail. Or, they may include an additional self-addressed return envelope, large enough to accommodate their canceled items, with sufficient postage affixed for return of their postmarked items. Mail the request for a first day of issue digital color postmark to the corresponding city of issuance. Post Offices will then forward all customer requests for digital color postmarks to Cancellation Services, Stamp Fulfillment Services, PO Box 449992, Kansas City, MO 64144-9992.

After applying the first day of issue postmark, the Postal Service will return the envelopes to the customer by U.S. Mail.

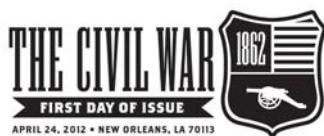
