## Holiday Season 2021

The Postal Service<sup>™</sup> is putting the finishing touches on what we expect will be a very busy 2021 peak season. Our employees are hard at work installing new machinery, dusting off the holiday-themed postmarks, and preparing for the influx of holiday mailings across the country. Here are some important details to help you prepare for your holiday shipping.



## Holiday Stamps

The Postal Service offers a wide variety of contemporary and religious stamps for the holidays. Customers may purchase these stamps at retail offices or online at *usps.com/ shop*. New stamps this year include:

- A Visit from St. Nick.
- Otters in the Snow.

Holiday stamps from previous years are also available:

- Hanukkah.
- Kwanzaa.
- Sparkling Holidays.
- Diwali.
- Eid.
- Global: Poinsettia.

As a reminder, the cost of a Forever<sup>®</sup> stamp increased in August from 55 cents to 58 cents.

## Military Mail

To send packages to loved ones serving in the military abroad, the Postal Service offers a discounted price of \$21.15 on its largest Priority Mail Flat Rate<sup>®</sup> box. The price includes a \$1.50 per box discount for mail sent to APO/ FPO/DPO destinations worldwide, and the temporary price increase in effect October 3 through December 26.

**Note:** There is a temporary price increase in effect for all retail and commercial domestic competitive parcels: PME, PM, FCPS, Parcel Select, USPS Retail Ground, and Parcel Return Service. International products are unaffected. The temporary rates went into effect at 12:00 A.M., Central Time, October 3, 2021, and will remain in place until 12:01 A.M., Central Time, December 26, 2021. Priority Mail Flat Rate boxes are available at no cost at local Post Offices or customers can order them online at *usps.com/freeboxes*. Customers may print postage, labels, and customs forms online anytime using the Click-N-Ship<sup>®</sup> feature at *usps.com/ship*.

To ensure timely delivery of holiday wishes by December 25, 2021, the Postal Service recommends that you send cards and packages to military APO/FPO/DPO addresses overseas no later than the mailing dates listed in the following table:

## **Military Care Kit**

The Postal Service has created a free Military Care Kit based on the items most frequently requested by military families. The kit contains:

- 1. Two APO/FPO/DPO Priority Mail Flat Rate boxes,
- 2. Two Medium Priority Mail Flat Rate boxes,
- 3. Priority Mail tape,
- 4. Priority Mail address labels, and
- 5. Appropriate customs forms.

To order the kit, call 800-610-8734. You can find guidelines for packing, addressing, and shipping items to U.S. troops at *usps.com/ship/apo-fpo-dpo.htm*. To order flat rate boxes featuring the "America Supports You" logo, go to *usps.com/freeboxes*.

## Addressing the Package

Use the following directions to properly address your military mail package:

- Write out the service member's full name.
- Include the unit and APO/FPO/DPO address with the 9-digit ZIP Code<sup>™</sup> (if one is assigned).

For example:

Army/Air Post Office (APO) COL MELANIE DOE PSC 3 BOX 4120 APO AE 09021

Fleet Post Office (FPO) SEAMAN JOSEPH SMITH UNIT 100100 BOX 4120 FPO AP 96691

## Diplomatic Post Office (DPO) JOHN DOE UNIT 8400 BOX 0000 DPO AE 09498-0048

- Do not write the country name where the service member is stationed in the address.
- Include a return address.
- Inside the box, include the service member's name and address as well as the sender's name and address on an index card in case the shipping label gets damaged in transit.

## **Busiest Mailing and Delivery Days**

Our busiest time is now 2 weeks before Christmas. Starting the week of December 6, customer traffic is expected to increase. The Postal Service predicts that the week of December 13–18 will be the busiest mailing, shipping, and delivery week for the holidays.

#### Skip the Trip and Ship Online

The Postal Service anticipates December 19 will be the busiest day online with 12.5 million customers predicted to visit *usps.com* for help shipping that special holiday gift. And *usps.com* is always open.

The Click-N-Ship feature (*usps.com/manage/package-intercept.htm*) and other online services allow customers to order free Priority Mail boxes\*, print shipping labels, purchase postage, and even request free next-day Package Pickup\*\*.

- \* Boxes are delivered in the U.S. with regular mail usually within 7 to 10 business days. Exclusions apply. For details and to order, visit store.usps.com/store.

## **New This Year**

There is a temporary price increase in effect for all retail and commercial domestic competitive parcels: PME, PM, FCPS, Parcel Select, USPS Retail Ground, and Parcel Return Service. International products are unaffected. The temporary rates went into effect at 12:00 A.M., Central Time, October 3, 2021, and will remain in place until 12:01 A.M., Central Time, December 26, 2021. The Postal Service will offer an expanded package delivery window — delivery in the morning, afternoon, early evening, and Sundays, where volume warrants.

The Postal Service has also expanded operational capacity with new equipment:

- 112 new package sorting machines, including:
  - 43 new single induction package sorters.
  - 38 new flex rover sorters.
- New material handling equipment.
- More than 70 logistics and mail processing annexes (rented for peak season).
- 44 package support annexes.
- 3,000 new tablets to assist mail processing supervisors.

#### Custom Solutions for Sending Holiday Packages

The Postal Service is uniquely qualified to deliver the holidays by offering a variety of custom solutions designed to make sending holiday packages easy:

- Packages that have stamps as postage and are more than one-half inch thick and/or weighing more than 10 ounces *must* be taken to a retail counter for drop off. Alternatively, customers can use a self-service kiosk for a postage label and drop off the package in a Post Office package slot, *not* a mail slot.
- Get free Priority Mail and Priority Mail Express boxes and envelopes in Post Offices or online at usps.com/ freeboxes.
- Skip the line and use self-service kiosks located in larger Post Offices to weigh, pay postage, and deposit your packages.
- Use the Click-N-Ship feature online at usps.com/ship to create shipping labels with USPS Tracking<sup>®</sup>, pay postage, or use flat rate shipping products to avoid weighing packages.
- With free Package Pickup, your package can be handed to your mail carrier on his or her regular delivery route or you can schedule a pickup. For details on availability, visit usps.com/pickup.
- Take your packages to the retail counter at any Post Office location.
- \* Boxes are delivered in the U.S. with regular mail usually within 7 to 10 business days. Exclusions apply. For details and to order, visit store.usps.com/store.

## Custom Solutions to Help With Receiving Holiday Packages

The Postal Service also offers a variety of custom solutions designed to make receiving holiday packages more convenient:

- Informed Delivery<sup>®</sup> (informeddelivery.com) is the free daily digital preview of what is coming to your mailbox. You can see what mail is coming to your mailbox, manage your packages by providing delivery instructions or reschedule delivery online, and see some exterior images of magazines and catalogs — all from your mobile app, dashboard, tablet, or computer.
- Customers can also request the package be held at a Post Office by choosing the Hold for Pickup option in the Informed Delivery app (*informeddelivery.com*), or online at *reg.usps.com/login?app=HOLD-MAIL&appURL=https%3A%2F%2Fholdmail.usps.com%2Fholdmail%2F*.
- Customers who know they won't be home when a package is delivered can use USPS Package Intercept<sup>®</sup> (usps.com/manage/package-intercept.htm). Before delivery, most domestic package shipments can be redirected back to the sender, to a new address (a neighbor, perhaps), or to the Post Office to be held for pickup.

#### Help Customers Avoid a Shipping Glitch

There are a number of things that customers can do to ensure their holiday mail gets delivered safely and correctly:

- Print addresses clearly and include all address elements, such as apartment numbers and directional information (ex., 123 S. Main St., Apt. 2B).
- Don't send materials that are prohibited, such as fireworks or ammunition. Hazardous materials like perfumes, aerosols, or lithium batteries are mailable with restrictions. For more information, visit pe.usps.com.
- Items powered by dry-cell batteries sometimes turn on during handling and emit a light, buzz, beep, or tick. Ensure your device is powered off or package batteries separately (preferably in the original manufacturer's packaging). *Note:* Specific packaging requirements apply to lithium batteries. For more information, see Publication 52, *Hazardous, Restricted and Perishable Mail* at *pe.usps.com/ HAZMAT/Index*.
- Place a card inside the package that contains the delivery and return address. This ensures the package can be delivered or returned if the mailing label gets damaged or falls off.
- Never guess a ZIP Code. NO ZIP is better than a WRONG ZIP. Look up a ZIP Code at usps.com under Quick Tools.
- Include both "to" and "from" information on packages and only on one side.
- Do NOT reuse mailing boxes they weaken in the shipping process.
- Select a box that is strong enough to protect the contents. Priority Mail and Priority Mail Express boxes are free at the local Post Office.
- Leave space for extra cushioning inside. Stuff glass and fragile, hollow items, like vases, with newspaper or packing material, to avoid damage. When mailing framed photographs, take the glass out of the frame and wrap it separately.

## Holiday Advertising Campaign

## Holiday Hiring

The Postal Service will be hiring seasonal employees across the country to meet operational needs and the needs of our customers. Hiring decisions are made at a local level. Instead of just hiring seasonally, the Postal Service is focusing its resources on actively hiring year-round.

## Employee Tipping

All Postal Service employees, including mail carriers, must comply with the Standards of Ethical Conduct for Employees of the Executive Branch. Under these federal regulations, carriers may accept a gift worth \$20 or less (this includes store, restaurant, or mall gift cards). However, carriers must never accept cash and cash equivalents, such as checks or gift cards that can be used like credit cards (with Visa, MasterCard, or American Express logos) for any amount.

## Carriers and Dogs

The Postal Service asks customers to place their dogs in a separate room before opening the front door to accept packages from carriers. Dogs are protective in nature and have been known to jump through screen doors and squeeze through door openings. More than 5,800 carriers were attacked by dogs last year. We want everyone to get home safely each day.

1. Personalize greeting cards as usual.

- 2. Address the envelopes.
- 3. Put a holiday stamp on each envelope.
- 4. Put all the envelopes in a larger envelope or a Priority Mail box
- 5. Put postage on the larger envelope or box.
- 6. The recommended mail-by date to receive a response before Christmas day is December 6, which will ensure all requests are received by the Anchorage postmaster no later than December 13.
- 7. Otherwise, use Priority Mail Express and send cards to:

# Get an "Official" Letter from Santa for Your Children

*Note:* Getting a letter from Santa is NOT the same as USPS Operation Santa.

This exciting program provides children with responses from the big guy at the North Pole. Follow these simple steps to get Santa Mail (complete with a North Pole Postmark) on your child's letter to Santa:

- 1. Have your child write a letter to Santa and place it in an envelope addressed to SANTA CLAUS, NORTH POLE.
- 2. Later, when alone, open the envelope and write a personalized response to the child on the back of the letter. Don't forget to sign it from Santa!
- 2. Insert the response letter into a separate envelope and address it to the child.
- 3. Add the return address to the envelope: SANTA CLAUS, NORTH POLE.
- 4. Affix a First-Class Mail stamp to the envelope.
- 5. Place the complete envelope into a larger envelope (preferably a Priority Mail Flat Rate envelope) with appropriate postage and address it to:

NORTH POLE POSTMARK POSTMASTER 4141 POSTMARK DR ANCHORAGE, AK 99530-9998

The recommended mail-by date is December 6 to receive a response before Christmas day. The Anchorage postmaster must receive the envelope no later than December 13. Santa's helpers in Anchorage, AK, will take care of the rest!

## IMM Revision: Termination of International Postal Money Order Service

Effective October 21, 2021, the Postal Service<sup>™</sup> is revising *Mailing Standards of the United States Postal Service*, International Mail Manual (IMM<sup>®</sup>), Exhibit 371.2, to reflect that the exchange of international postal money orders between the Postal Service and Trinidad and Tobago Postal Corporation (TTPost) will be discontinued as of January 1, 2022.

Effective January 1, 2022, TTPost will stop selling international postal money orders destined for the United States. Likewise, effective January 1, 2022, the Postal Service will stop selling international postal money orders destined to TTPost. A customer who wishes to purchase an international postal money order destined for Trinidad and Tobago must do so before January 1, 2022.

Effective January 1, 2023, TTPost will stop cashing international postal money orders issued by the Postal Service. Likewise, effective January 1, 2023, the Postal Service will stop cashing international postal money orders issued by TTPost. Consequently, in accordance with IMM 371.5, a customer in possession of an international postal money order issued by TTPost must cash it at a U.S. Post Office<sup>™</sup> facility by the validity date on the money order or before January 1, 2023, whichever comes first.

A customer who is in possession of a USPS-issued international postal money order but who does not cash it before January 1, 2023, may redeem it at a U.S. Post Office facility at face value.

Effective October 1, 2022, the foreign post will stop cashing international postal money orders issued by the Postal Service. Likewise, effective October 1, 2022, the Postal Service will stop cashing international postal money orders issued by the post.
- (3) In Barbados the amount of the money due for payment will no longer be handwritten on Form MP1 (the form currently states "Amount to Be Written in Words") but will be electronically applied.
- (4) Jamaica and Trinidad and Tobago will not issue money orders in U.S. dollars.
- (5) Effective January 1, 2022, Trinidad and Tobago will stop selling international postal money orders destined for the United States. Likewise, effective January 1, 2022, the Postal Service will stop selling international postal money orders destined to Trinidad and Tobago. Effective January 1, 2023, Trinidad and Tobago will stop cashing international postal money orders issued by the Postal Service. Likewise, effective January 1, 2023, the Postal Service will stop cashing international postal money orders issued by Trinidad and Tobago.

\* \* \* \*

Although effective October 21, 2021 (even though the policy itself is not effective until January 1, 2022), the Postal Service will incorporate this revision into a later edition of the online IMM, which is available via Postal Explorer<sup>®</sup> at *pe.usps.com*.

## Publication 52 Revision: Cigarettes, Smokeless Tobacco, and Electronic Nicotine Delivery Systems

Effective October 21, 2021, the Postal Service<sup>™</sup> is revising Publication 52, *Hazardous, Restricted, and Perishable Mail* (Pub 52), part 47, to incorporate new federal statutory restrictions on mailing electronic nicotine delivery systems (ENDS), including their liquids, parts, components and accessories.

Such items will be subject to the same prohibitions as cigarettes and smokeless tobacco due to the enactment of the Preventing Online Sales of E-Cigarettes to Children Act on December 27, 2020. The Act adds ENDS to the definition of "cigarettes" under the Jenkins Act and prohibits mailing ENDS unless they qualify for an exception.

These changes to Pub 52 will align Postal Service mailing standards with the new federal law by including ENDS and the associated mailability exceptions based on the new federal statute. For more detailed information, refer to the final *Federal Register* notice, *Treatment of E-Cigarettes in the Mail*, at *federalregister.gov*.

Although effective October 21, 2021, the standards will not be published in Pub 52 until a future edition. Pub 52 is available online via Postal Explorer<sup>®</sup> at *pe.usps.com*.

## Christmas Pay Procedures for Rural Carriers

The 2021 Christmas period for rural carriers begins Saturday, December 4, 2021 (Week 1, Pay Period (PP) 26-2021), and ends Friday, December 24, 2021 (Week 1, Pay Period 01-2022). During this period, certain timekeeping and pay rules apply. Timekeepers, including postmasters, supervisors, and other employees responsible for rural carrier time and attendance recording, must become familiar with Article 9.2.K., Christmas Allowances and Procedures, of the 2018–2021 USPS/National Rural Letter Carriers' Association (NRLCA) Agreement.

This article describes:

- Types of compensation to which rural carriers are entitled during the Christmas period.
- Related timekeeping procedures and regulations for the Christmas period.
- Special rules that begin with the start of the Guarantee Year (October 9, 2021) and continue through the end of the Christmas period (December 24, 2021).

The preferred method of timekeeping data entry is through the Rural Management Support System (RMSS) web application. The following information provides USPS<sup>®</sup> guidelines for Rural Carrier compensation during the designated Christmas period. These instructions are designed for Manual Timekeeping and TACS data entry.

## **Overtime During the Christmas Period**

Regular Carriers (Des 71) - FLSA B

## **Types of Overtime**

During the Christmas period, regular rural carriers are eligible for two types of overtime — FLSA overtime and Christmas overtime.

## **FLSA Overtime**

FLSA overtime is paid at all times of the year, not just during the Christmas period. Regular rural carriers are paid FLSA overtime under two circumstances:

- a. Hours worked in excess of 12 hours in a day. If a carrier works more than 12 hours in a day, the amount over 12 is entered in the Daily Overtime block on PS Form 1314.
- b. Hours worked in excess of 56 in a week. These hours are calculated automatically when the total weekly work hours are greater than 56, so no separate entries are required.

## **Christmas Overtime**

Christmas Overtime is paid only during the designated Christmas period. Regular rural carriers are paid Christmas overtime under two circumstances:

a. Christmas Assistance — This is assistance provided by the regular carrier on his or her relief day. Christmas assistance work hours are entered in the Xmas Assist Work Hours block on PS Form 1314. b. Hours worked in excess of the route's evaluation — This is based on the total actual work hours for the week, not on individual days. For example, if a route has a daily evaluation of 9 hours and the regular carrier works 10 hours on 2 days, and 8 hours on the other 3 days, no overtime would be paid. Even though the carrier exceeded the daily evaluation on 2 days of the week, he or she did not exceed the *weekly* evaluation. The weekly evaluation is 45 hours; the carrier worked 44 hours. (See Handbook F-21, part 567, for overtime calculation when leave days are taken during the week and for routes with an evaluation of less than 40 hours.) These hours are calculated automatically, so no separate entries or calculations are required.

#### **Overtime Rate**

The overtime rate paid to regular (FLSA Code B) carriers is 150 percent of the carrier's regular rate. The regular rate is determined by dividing the total compensation received for hours actually worked by the carrier since the beginning of the Guarantee Year (not including overtime), by the total number of hours worked since the beginning of the Guarantee Year (not including overtime). This overtime rate is used for both FLSA overtime and Christmas overtime.

#### **Replacement Carriers**

Replacement Carriers (Designations 70, 73, 74, 75, 76, 77, 78, and 79) are only entitled to FLSA overtime. For these employees, FLSA overtime is paid for hours worked in excess of 40 in a week.

## Regular Carriers (Des 71) - FLSA A

Regular carriers whose FLSA code is A are paid for actual hours worked, not evaluated hours. They are paid overtime for hours in excess of 8 in a day or 40 in a week. For FLSA Code A carriers, enter hours in excess of 8 in a day to the Daily Overtime block on PS Form 1314. Hours in excess of 40 in a week are calculated automatically.

#### Auxiliary Route Carriers

Carriers serving any auxiliary route are compensated at the **hourly rate** for actual hours worked during PP 26-2021 and Week 1 of PP 01-2022. During this period, carriers are not paid the evaluation of the route. Overtime is paid only when the carrier exceeds 40 hours for the week.

#### **Christmas Assistance**

Christmas assistance is additional service provided on a rural route during the Christmas period. For regular carriers, Christmas assistance applies only to assistance given by the carrier, on his or her relief day, while a replacement carrier is assigned to work the full route. For replacement carriers, it applies to any assistance provided on a regular or auxiliary route during the Christmas period. Christmas assistance is reported in the Xmas Assist Work Hours block on PS Form 1314 (for regular carriers) or PS Form 1314-A (for replacement carriers).

Regular carriers can perform Christmas assistance only on their relief day. Therefore, only regular carriers assigned to J or K routes may report Christmas assistance. Regular carriers assigned to route types H or M cannot perform Christmas assistance because these route types do not have a relief day. **Note:** In accordance with an Agreement between the parties, regular rural carriers may perform service on Sunday or provide auxiliary assistance on other routes in the office. This is considered FLSA (daily OT), not Christmas assistance.

#### **Examples of Christmas Assistance:**

- A regular carrier comes in on his or her relief day and helps the replacement carrier case the route.
- A regular carrier comes in on his or her relief day and carries part of his or her regular route. (Replacement carrier is listed on PS Form 1314.)
- A replacement carrier carries part of a regular route due to heavy Christmas volume.

These are **NOT** examples of Christmas assistance:

- A regular carrier comes in on his or her relief day, and cases and carries his or her regular route.
- A regular carrier works 2 hours beyond the daily evaluation of his or her regular route.
- A regular carrier performs any work while assigned to an H or M route.

 Daily Overtime — For FLSA B carriers, this block is used ONLY to record when the carrier works more than 12.00 hours in a single day. (See Exhibit 5 for use of this block for FLSA Code A regular carriers. This block is not used for FLSA Code P.) Record the total amount of work hours in excess of 12 per day in this box. *Include the amount of daily overtime in the Actual Weekly Hours block*. For example, if the carrier works 10.00 hours each day, Monday through Wednesday, and works 12.50 on Thursday and 13.00 on Friday, the amount entered into the Daily Overtime block is 1.50 and the amount entered into the Actual Weekly Hours is 55.50. Do not enter a decimal point when entering work hours.

The Daily Overtime block is **NOT** used to record:

- Hours worked in excess of 56 in a week.
- Hours worked in excess of the route's evaluation.
- Hours worked when the carrier works his or her relief day.
- Additional hours worked by the carrier after completing his or her route (except for those that are over 12 hours for the day).
- Xmas Assist Work Hours For FLSA Code B regular carriers, this block is used ONLY when the carrier comes in on his or her relief day to *provide assistance*, not to serve his or her full route. A relief carrier must be listed on PS Form 1314 as the replacement carrier for that day. Do NOT include the amount of Xmas Assist Work Hours in the Actual Weekly Hours block.

The Xmas Assist Work Hours block is **NOT** used to record:

- Hours worked in excess of 56 in a week.
- Hours worked in excess of the route's evaluation.
- Hours worked when the carrier works his or her relief day and DACA Code R, 3, or 5 is entered on the PS Form 1314.
- Additional hours worked by the carrier after completing his or her route.

Auxiliary route — assistance provided by Des 79 on assigned route	Use PS Form 1314-A for assigned route

2. Xmas Assist Work Hours — This block is used whenever a replacement carrier provides Christmas assistance. **Do not** *include the amount of Xmas Assist Work Hours in the Actual Weekly Hours block.* 

## Work on Relief Days and Use of X Days

During the period from the beginning of the Guarantee Year (October 9, 2021), through the last day of the Christmas period (December 24, 2021) — which includes pay periods 22-2021, 23-2021, 24-2021, 25-2021, 26-2021, and 01-2022 (Week 1) — record relief days worked by regular rural carriers on PS Form 1314, as described below.

- Carriers who work a relief day during this period and who are entitled to a future day off (X day) must be given that X day in the same pay period. Record DACA Code R or 3 on PS Form 1314 for the relief day that is worked, and DACA Code X on the day that is taken off. The Rural Time and Attendance Collection System (RTACS) will not accept any PS Form 1314 that contains a DACA Code 3 or DACA Code R without a corresponding DACA Code X.
- 2. Record DACA Code 5 on PS Form 1314 for the relief day that is worked if an X day is not taken in the same pay period that the relief day is worked, or if the carrier is on the relief day work list and selects the option

for 150 percent compensation. When DACA Code 5 is entered, the carrier does not receive an X day.

- Carriers may not use any X days that were earned in previous pay periods during this period. RTACS will not accept any PS Form 1314 that contains a DACA Code X without a corresponding DACA Code 3 or DACA Code R.
- 4. Carriers must have a sufficient balance of X days available in order to use an X day. Carriers with a negative X day balance cannot use any X days until the negative balance is erased.

## **Christmas Period Timekeeping Instructions**

A. FLSA B Regular Rural Carriers

- Work on Relief Day Only regular carriers on J or K routes have an assigned relief day. Any work performed by a regular on his or her relief day must be reported in one of the following ways:
  - a. Regular carries entire route If the carrier reports on the relief day and cases and carries

the assigned route (as is done on a scheduled day), enter DACA Code R, 3, or 5 (as appropriate) on PS Form 1314 for that day. If the carrier is due an X day for working the relief day (e.g., DACA Code R or 3 is entered), this X day must be granted in the same pay period. If the X day is not granted within the same pay period, DACA Code 5 must be entered on PS Form 1314.

- b. Christmas assistance If a relief carrier serves the assigned route and the regular carrier provides assistance on the relief day, record the hours worked by the regular as Xmas Assist Work Hours. If additional Equipment Maintenance Allowance (EMA) is due for work performed on the relief day, enter the mileage traveled in whole miles in the Route Deviation block for the appropriate week. Do **NOT** include these hours in the Actual Weekly Hours block. Enter J or K in the appropriate block on PS Form 1314 if the replacement carrier worked a full day on the route.
- B. FLSA Code A Regular Carriers

Regular carriers (FLSA Code A) are paid at the regular rate for all hours worked up to 8 per day and 40 per week, and at the overtime rate for all hours worked in excess of 8 per day or 40 per week. FLSA Code A employees are not entitled to any X days as they are paid for working the relief day.

- 1. Report total hours worked for the week in the Actual Weekly Hours block.
- 2. If the carrier worked more than 8.00 hours in a day, enter total hours worked in excess of 8 for that day in the Daily Overtime block.
- 3. If the carrier worked on a scheduled relief day, enter R on the day the carrier worked the relief day and include the hours worked in the Actual Weekly Hours block. The employee is **NOT** entitled to a future X Day.
- C. Auxiliary Route Carriers

Carriers serving any auxiliary route are compensated at the hourly rate for actual hours worked during PP 26-2021 and Week 1 of PP 01-2022. During this period, carriers are not paid the evaluation of the route (this includes newly hired RCAs in the first five pay periods of training). The only changes to standard timekeeping procedures for auxiliary routes are when a Designation (Des) 79 provides Christmas assistance on the assigned auxiliary route. (See section E, item 2).

D. Replacement Carriers Assigned to Vacant Regular Routes (Designations 72/74)

- 1. Designation 72
  - a. FLSA B Procedures are the same as for Des 71 (Regular Carrier), FLSA B.
  - b. FLSA A Procedures are the same as for Des 71 (Regular Carrier), FLSA A.
- 2. Designation 74

Work on relief day

- a. Carrier worked scheduled relief day:
  - (1) Enter R on the day the carrier worked the relief day.
  - (2) Include the hours worked in the Actual Weekly Hours block. The employee is **NOT** entitled to a future X Day.
- b. Carrier provided Christmas assistance on relief day:
  - Enter the Christmas auxiliary assistance time on PS Form 1314 in the Xmas Assist Work Hours block.
  - (2) Do **NOT** include these hours in the Actual Weekly Hours block.
  - (3) Enter J or K in the appropriate block on PS Form 1314 if the replacement carrier worked a full day on the route.
- E. Replacement Rural Carriers Serving as Christmas Auxiliary Assistants

All replacement carriers serving as Christmas auxiliary assistants are compensated at their regular rate for actual hours worked up to 40 per week, and at the FLSA overtime rate for actual hours worked in excess of 40.

- 1. Christmas assistance on a regular route:
  - a. Manually prepare PS Form 1314-A for each carrier that provides Christmas assistance.
  - b. Do **NOT** enter more than one carrier on each PS Form 1314-A.
  - c. Submit a separate certificate for each regular route on which the carrier provides assistance.
  - Report the Christmas assistance hours in the appropriate Week 1 and/or Week 2 Xmas Assist Work Hours block.
  - e. Enter EMA hours, trips, and miles in the appropriate Week 1 and/or Week 2 EMA blocks.
- 2. Christmas assistance on an auxiliary route:
  - a. Assigned carrier (Des 79) provided Christmas assistance on assigned auxiliary route:
    - Enter N in the appropriate block in the No Service section of the carrier's PS Form 1314-A for the assigned route.

- (2) Record hours worked in the Xmas Assist Work Hours block. Only enter Christmas assistance when the Des 79 assists the replacement carrier working the N day.
- (3) Include EMA hours and miles (not trips) in the total for the appropriate week. Trips may not exceed the number of days worked in the No Service blocks.
- (4) A replacement carrier is required to crossfoot the card.
- B. Replacement carrier (Designations 70, 73, 74, 75, 76, and 78) provided Christmas assistance on auxiliary route:
  - Manually prepare PS Form 1314-A. Enter route number A997. Use this route type and number for overburdened service or Christmas assistance on auxiliary routes only.
  - (2) Report the Christmas assistance hours in the appropriate Week 1 and/or Week 2 Xmas Assist Work Hours block.
  - (3) Enter EMA hours, trips, and miles (if applicable) in the appropriate Week 1 and/or Week 2 EMA blocks.
  - (4) If Christmas assistance is performed on two or more auxiliary routes in the same pay period, combine all work hours and EMA data on one manually prepared PS Form 1314-A.
- F. Postal Employees (Other Than Rural) Serving as Christmas Auxiliary Assistants

Postal Service employees (other than Des 7X) who provide Christmas assistance on rural routes are compensated at their regular rate of pay for actual time worked. Include all work hours using their normal Time and Attendance System (Manual Timecards or TACS).

Nonrural employees are entitled to EMA payment if a personal vehicle is used. Prepare PS Form 1314-A as

follows: (Do **NOT** prepare PS Form 1314-A if a government vehicle is provided.)

Organization Information

- 1. Report the hours worked on the rural routes on PS Form 1230-C, *Time Card*.
- 2. Manually prepare PS Form 1314-A for EMA compensation. Complete indicative data at the top of the certificate. Use Des/Act 99-0, actual route type and number, FLSA code P, and correct employee and pay period information.
- 3. Enter EMA hours, trips, and miles in the appropriate Week 1 and/or Week 2 EMA blocks.

# Important Items to Remember: Rural Carrier Christmas Pay Procedures

- Hours entered in the Daily Overtime block are always included in Actual Weekly Hours.
- Hours entered in the Xmas Assist Work Hours block are **NOT** included in the Actual Weekly Hours block.
- Carriers on auxiliary routes are paid for actual hours worked, not the route's evaluation, during the Christmas period.
- During the period from the beginning of the Guarantee Year (October 9, 2021) through the last day of the Christmas period (December 24, 2021), a DACA Code X cannot be entered on a timecard unless there is a corresponding DACA Code R or 3 in the same pay period and the carrier's X day balance is zero or greater.
  - DACA R and 3 require a DACA Code X to be used in the same pay period.
- If Actual Weekly Hours exceed 56 hours in a week, a DACA Code 5 must be used. DACA Code R or 3 are not allowed.
- If a regular carrier works his or her relief day and serves his or her assigned route, this is **NOT** reported as Christmas assistance.
- Second trip is not allowed during the Christmas period.

## Verifying U.S. Postal Service Money Orders

Follow these steps to cash a Postal Service<sup>™</sup> money order:

- 1. Check that the amount does not exceed the legal limit: \$1,000 for domestic, and \$700 for international Postal Service money orders.
- 2. Check that the proper security features are present:
  - When held to the light, a watermark of Benjamin Franklin is repeated from top to bottom on the left side.
  - When held to the light, a dark line (security thread) runs from top to bottom with the word "USPS" repeated.
  - When there is discoloration around the dollar amounts, this might indicate the amounts were changed.

These appear in Postal Service Notice 299, U.S. Postal Money Order Reference Card, or online at usps.com/shop/money-orders.htm.

3. If the money order seems suspicious, call the U.S. Postal Service Money Ordxxer Verification System at 866-459-7822.

Provide this information to local banks and retailers, as they also receive Postal Service money orders for cashing.

B. Other than for PMEMS and the exceptions listed below, a customs declaration PS Form 2976 or PS Form 2976-A is required for all items weighing 16 ounces or more, and for all items (regardless of weight) containing potentially dutiable mail contents (e.g., merchandise or goods) addressed to or from this ZIP Code. Other than the exceptions listed below, all PMEMS mailpieces (regardless of mail contents or weight) addressed to or from this ZIP Code must bear a properly completed PS Form 2976-B. The surface area of the address side of the mailpiece must be large enough to contain the applicable customs declaration. The following exceptions apply to known mailers, who for this purpose are defined as follows:

- Business mailers who enter volume mailings through business mail entry units or other bulk mail acceptance locations, pay postage through advance deposit accounts, use permit imprints for postage payment, and submit completed postage statements at the time of entry that certify that the mailpieces contain no dangerous materials that are prohibited by postal regulations. Such business mailers are exempt from providing customs documentation on non-dutiable letters and printed matter.
- All federal, state, and local government agencies whose mailings are regarded as "Official Mail." Such agencies are exempt from provid-. ing customs documentation, except for any items addressed to an MPO or DPO to which restriction "B2" applies.

B2. All federal, state, and local government agencies must complete customs documentation when sending potentially dutiable mail addressed to or from this MPO or DPO.

C. Cigarettes and other tobacco products, including tobacco leaves, chewing and pipe tobacco, snuff, and cigars are prohibited, including those that are authorized in Publication 52 under PACT.

C1. Obscene and horror articles, images, prints, paintings, cards, films, videotapes, comic books, etc., are prohibited.

C2. E-cigarettes and related products (e.g., nicotine liquids, e-liquids, parts, or supplies) are prohibited.

D. Coffee is prohibited.

E. Medicines (prescription, over-the-counter, vitamins, and supplements) are prohibited when mailed to individuals for human or animal use. E1. Mailers are responsible to ensure that all medicines and vaccines conform to host nation laws.

E2. Any matter depicting nude or seminude persons, pornographic, or sexual items are prohibited. Non-authorized political materials are prohibited. Religious materials contrary to the Islamic faith are prohibited in bulk quantities, but individual items for the personal use of the addressee are permissible.

E3. Radio transceivers, cordless/cellular telephones, global positioning systems, scanners, base stations, and handheld transmitters are prohibited.

F. Firearms of any type are prohibited, except firearms mailed to or by official U.S. government agencies. This restriction does not apply to firearms mailed from this MPO ZIP Code, provided ATF and USPS regulations are met. Antique firearms do not require an ATF form.

F1. Weapons of any type are prohibited.

F2. Mailing firearms to or from this MPO ZIP Code is restricted to one shotgun and one single shot .22 caliber rifle per individual.

F3. Replica weapons and inert explosive devices (such as grenades) and weapons parts are prohibited.

G. Parcels of any class are prohibited.

H. Meats, including preserved meats, bones, skin, hair, feathers, horns or hoofs of hoofed animals, and wool samples whether hermetically sealed or not, are prohibited.

H1. Pork or pork by-products are prohibited.

I. Reserved for future use.

The Board currently has contracts with BlackRock Institutional Trust Company, N.A., to manage the F, C, S, and I Fund assets. The F, C, S, and I Funds invest in commingled trust funds, in which the assets of tax-deferred employee benefit plans are combined and invested together. The F, C, S, and I Funds and the BlackRock funds are passively managed index funds. Future performance of the funds will vary and may be significantly different from the returns shown above. - 6. No manual computation for Christmas overtime is necessary. This is automatically computed. The carrier will receive 0.32 hours of overtime in Week 1 and 0.08 hours of overtime (34.08 + 06.00 = 40.08 hours) in Week 2.



Following the principle of least privileges limits access rights for users to the bare minimum needed to do their work. No access to a system or resource is granted unless it's absolutely necessary.

Here are a few ways to maintain the principle of least privileges:

 Revoking Access. Managers must ensure that information access is immediately revoked for personnel because of a change in job, transfer, or termination. During National Cybersecurity Awareness Month, CyberSafe at USPS<sup>®</sup> will highlight the various Corporate Information Security Office's portfolios and briefly describe their roles in securing the USPS<sup>®</sup> network.

   Managers and functional system coordinators must review the access rights for each of their assigned users on a predetermined schedule:
  - Employee access must be reviewed twice every year.
  - Contractor access must be reviewed quarterly every year.
- Pending Actions. Whenever an MPR is due, eAccess will send an email with a link directing you to the pending task. The message "MPR" will also appear in the "Pending Actions" area of the Manager tab in eAccess.

To strengthen USPS security and ensure adherence to the principle of least privileges, refer to the user access management policies in section 9-3 of Handbook AS-805 (*about.usps.com/handbooks/as805/as805c9\_003.htm*).

### **Pictorial Postmarks Announcement**

As a community service, the Postal Service<sup>™</sup> offers pictorial postmarks to commemorate local events celebrated in communities throughout the nation. A list of events for which pictorial postmarks are authorized appears on the following pages. The sponsor of the pictorial postmark appears in italics under the date. Also provided are illustrations of these postmarks.

People attending these local events may obtain the postmark in person at the temporary Post Office<sup>™</sup> station established there. Those who cannot attend the event but who wish to obtain the postmark may submit a mail order request. Pictorial postmarks are available only for the dates indicated, and requests must be postmarked no later than 30 days following the requested pictorial postmark date.

All requests must include a stamped envelope or postcard bearing at least the minimum First-Class Mail<sup>®</sup> postage. Items submitted for postmark may not include postage issued after the date of the requested postmark. Such items will be returned unserviced.

Customers wishing to obtain a postmark must affix stamps to any envelope or postcard of their choice, address the envelope or postcard to themselves or others, insert a card of postcard thickness in envelopes for sturdiness, and tuck in the flap. Place the envelope or postcard in a larger envelope and address it to: Pictorial Postmarks, followed by the Name of the Station, Address, City, State, ZIP+4<sup>®</sup> Code, as listed next to the postmark.

Customers can also send stamped envelopes and postcards without addresses for postmark, as long as they supply a larger envelope with adequate postage and their return address. After applying the pictorial postmark, the Postal Service returns the items (with or without addresses) under addressed protective cover.

# How to Order the First-Day-of-Issue Digital Color or Traditional Postmarks

Customers have 120 days to obtain the first-day-ofissue postmarks by mail. Each cover must have sufficient postage to meet First-Class Mail<sup>®</sup> requirements. Customers may purchase new stamps at their local Post Office<sup>TM</sup>, by phone at 844-737-7826, or on The Postal Store<sup>®</sup> website at *usps.com/shop*.

### **Digital Color Postmarks**

Only select stamp issues offer a digital color postmark. Customers may submit #6 or #10 envelopes constructed of paper rated as "laser safe." The Postal Service™ recommends envelopes of 80-pound Accent Opaque, acid-free, 9/16-inch side seams with no glue on the flap. The maximum size of all digital color postmarks is 2 inches (vertically) by 4 inches (horizontally). Allow sufficient space on the envelope to accommodate the postmark. Do not use self-adhesive labels for addresses on the envelope. Two test envelopes must be included. There is a minimum of 10 envelopes at 50 cents per postmark required at the time of servicing. Customers must submit a check, money order, or credit card for payment.

The Postal Service reserves the right to not accept hand-painted and other cachet envelopes that are not compatible with our digital color postmark equipment. The Postal Service also reserves the right to substitute traditional black rubber postmarks if use of nonspecified envelopes results in poor image quality or damage to equipment.

Customers must affix the stamps to the envelopes and address them to themselves or others for return through the mail. Or, they may include an additional self-addressed return envelope, large enough to accommodate their canceled items, with sufficient postage affixed for return of their postmarked items. After applying the first-day-of-issue postmark, the Postal Service will return the envelopes to the customer by U.S.  $Mail^{\textcircled{R}}$ .

### **Traditional Postmarks**

Customers must affix the stamps to the envelopes and address them to themselves or others for return through the mail. Or, they may include an additional self-addressed return envelope, large enough to accommodate their canceled items, with sufficient postage affixed for return of their postmarked items. Address customer requests for traditional postmarks to:

After applying the first-day-of-issue postmark, the Postal Service will return the envelopes to the customer by U.S. Mail<sup>TM</sup>. There is no charge for the first 50 postmarks. There is a 5-cent charge for each additional postmark over 50. Customers must submit a check, money order, or credit card for payment.

Locally produced items are not authorized. Only merchandise that has been approved and assigned an item number by Headquarters Retail Marketing may be produced and sold.
