DMM REVISION

Group E (No Fee) Post Office Box Service — Policy Changes

Effective July 2, 1998, *Domestic Mail Manual* (DMM) D910 is revised to clarify the standards for Group E post office box service. The revisions reflect three types of change.

The first change is to extend eligibility for Group E post office box service to all customers who reside or have businesses located in the geographic ZIP Code delivery area of a post office who are ineligible for carrier delivery for operational reasons. Previously, those customers who lived within one-quarter mile of post offices that provided rural carrier delivery were generally ineligible for Group E box service, but eligible for permanent general delivery service. Such customers are now eligible for Group E box service, but no longer have an option for permanent general delivery service.

The second change pertains to the box size provided to Group E customers. Previously, Group E customers at nondelivery offices could obtain any size box while such customers at other offices could only obtain the smallest available box. All Group E customers will now be treated alike and may obtain the smallest size that reasonably accommodates their incoming mail volume.

The third change updates the description of post office box service to reflect its current attributes.

This revision will appear in DMM 54.

Background

Group E post office box fees first arose as a consequence of a Postal Service Board of Governors decision that was placed into effect via final regulations published in the *Federal Register* on June 10, 1997 (62 FR 31512-16). At that time, the Postal Service was concerned with limiting the impact of Group E fees, and accordingly provided that Group E customers in delivery offices were only eligible to obtain service via the smallest available box. (Discretion to impose a similar size limit in nondelivery offices was unavailable under the Domestic Mail Classification Schedule.) Finally, customers located within a quarter mile of rural delivery offices and thus ineligible for carrier delivery, were provided a continued entitlement to their existing form of free delivery, general delivery service, but not Group E post office box service.

Having gained experience with Group E fees, including information on the number of eligible customers, the Postal Service determined to standardize the terms of and eligibility for Group E box service. This process was begun with a policy change, effective April 5, 1998, that extended Group E box service to customers who are ineligible for carrier delivery due to the close proximity (i.e., within a quarter mile) of their physical addresses to the post office. (Note: On June 8, 1997, Group E box service was first made available to customers whose residence or place of business was ineligible for any type of carrier delivery; however, quarter-mile customers were specifically excluded from consideration.) All customers who are ineligible for carrier delivery will now qualify for no-fee box service, unless the ineligibility arises from state or local laws which prohibit the installation of receptacles at the curb, or otherwise preclude the provision of carrier delivery service. See *Postal Operations Manual* (POM) 631.43.

Administration

Each post office box customer must have a complete and accurate PS Form 1093, *Application for Post Office Box or Caller Service*, on file at the post office providing box service. Postmasters must verify customers' physical addresses and may require customers to provide appropriate proof (see DMM D910.2.4). Group E box customers must verify their continued eligibility with the postmaster on an annual basis by completing and returning Notice 32-N, *No-Fee Post Office Box Service — Annual Renewal/Verification*. Notice 32-N was recently created to facilitate documentation of Group E box service. There will be an automatic distribution of Notice 32-N to field offices in early August 1998. Do not requisition Notice 32-N (PSIN NOT 32N, PSN 7610-04-000-5093) or PS Form 1093, both dated July 1998, from the material distribution center until August 1998. Postmasters and station managers must exhaust current in-office supplies of PS Form 1093 before ordering the revised form.

1.0 BASIC INFORMATION

1.1 Purpose

Post office box service is a premium service offered for a fee to any customer requiring more than free carrier delivery or general delivery and for no fee to customers who are not eligible for carrier delivery. The service allows a customer to obtain mail during the hours the box lobby is open or access is otherwise available. Post office box service is provided only through receptacles owned or operated by the Postal Service or its agents. Post office box service does not include alternate means of delivery established to replace, simplify, or extend carrier delivery service. A postmaster and a box customer may not make any agreement that contravenes the regulations on post office box service or its fees.

4.8 Exception for Group D Offices

Postmasters at Group D offices with fewer than 500 post office boxes may set April 1 and October 1 as the beginning of payment periods for box customers in their offices. Payment periods beginning other than April 1 or October 1 are brought into alignment with these respective dates by adjusting fees as follows:

5.0 FEE GROUP ASSIGNMENTS

5.1 Post Offices

- a. Post Office With City Delivery. A post office that provides city carrier delivery at any of its administered facilities applies Group C fees, except as provided in 5.3. A customer whose physical residence or business location is within the geographic delivery ZIP Code boundaries administered by that city delivery post office, who is ineligible for any form of carrier delivery service from that post office and who does not receive carrier delivery via an out-of-bounds delivery receptacle, may obtain post office box service through one

box of the smallest available size that accommodates the customer's mail volume at the Group E fee. A customer must pay the appropriate Group C fee for each additional box requested beyond the initial box obtained at the Group E fee. Each eligible customer, whether residential or business, is entitled to one box at the Group E fee for each eligible location, defined as a single potential delivery point.

- b. Post Office With Only Rural or Highway Contract Carrier Delivery or One With No Carrier Delivery. A post office that does not provide city carrier delivery at any of its administered facilities applies Group D fees, except as provided in 5.3. A customer whose physical residence or business location is within the geographic delivery ZIP Code boundaries administered by that non-city delivery post office who is ineligible for any form of carrier delivery service, and who does not receive carrier delivery via an out-of-bounds delivery receptacle may obtain post office box service through one box of the smallest available size that accommodates the customer's mail volume at the Group E fee. A customer must pay the appropriate Group D fee for each additional box requested beyond the initial box obtained at the Group E fee. Each eligible customer, whether residential or business, is entitled to one box at the Group E fee for each eligible location, defined as a single potential delivery point.

A permit imprint indicia on First-Class Mail or Priority Mail must show "First-Class Mail" or "Priority Mail" (or "Priority"), as applicable; "U.S. Postage Paid"; city and state; and permit number. The "Priority Mail" (or "Priority") marking may be omitted when using USPS-provided Priority Mail envelopes and containers. The indicia may show the mailing date, amount of postage paid, or the number of ounces for which postage is paid. The ZIP Code of the permit holder may be shown directly after the state name or in a separate inscription reading "ZIP Code 00000," when that ZIP Code does not create uncertainty about the permit holder's correct address or permit number. Instead of printing the city and state of mailing in the indicia, the mailer may print "Mailed From ZIP Code," followed by the 5-digit ZIP Code assigned to the postmaster of the mailing office. The indicia may also include required rate markings.

CMRS REPORTING CHANGES

CMRS Reporting for Ascom Hasler, Frieden Neopost, and Postalia Discontinued

Effective Accounting Period (AP) 8, Postal Fiscal Year 1998, Ascom Hasler, Frieden Neopost, and Postalia are no longer required to send hard copy Computerized Meter Resetting System (CMRS) reports to post offices. The AP 7 CMRS resetting report is the final hard copy report that post offices will receive. Therefore, post offices and district accounting offices are no longer required to report CMRS resetting on the back side of the Statement of Account. The Minneapolis Accounting Service Center will continue to post CMRS revenue to the applicable finance number, as is done with Pitney Bowes.

The Postmaster Account and Standard Field Accounting System will be reprogrammed to exclude the CMRS data input screens. PS Form 1555, *Statement of Account*, will also be revised to eliminate the CMRS section.

NMATS Provides Data

The introduction of the daily electronic meter file transfer will result in the following changes in the recording of information:

- National Meter Accounting and Tracking System (NMATS) provides meter information pertaining to customers, meter resets, meter movement activity, or inspection data.
- District accounting offices, upon request, provide CMRS meter revenue information to post offices.
- Post offices are not required to contact Ascom Hasler, Frieden Neopost, Postalia, Pitney Bowes or meter customers to obtain meter revenue or readings.

IRS FORM 1099-MISC UPDATE

IRS Form 1099-MISC New Reporting Requirements and \$600 Reporting Threshold Clarification

Effective for calendar year 1998, the Postal Service is required to report to the IRS all payments to corporations for services rendered in excess of \$600 on IRS Form 1099-MISC. This includes rents and other income as well.

Post offices processing payments through the Accounts Payable Accounting and Reporting System (APARS) should comply with this new reporting requirement when establishing vendors as 1099 reportable. However, it will not be necessary to adjust any vendor records for corporations previously established as not reportable. Compliance for tax year 1998 will be accomplished by system modifications based on the general ledger accounts for 1099 reportable payments.

All non-SFAS sites are required to review their first quarter 1998 vendor payments and to submit a supplemental log for corporations that would now be subject to this new IRS reporting requirement for corporations. Please ensure that all payments for services, rents, and other income, including those by corporations, are reported on future quarterly submissions.


For calendar year 1999, 1099 reporting will be captured at the time invoices are processed in accordance with the identified accounts. It will no longer be necessary to identify 1099 reportable payments when establishing vendor records in APARS. A *Postal Bulletin* will be issued at a later date outlining the 1099 processing for calendar year 1999.

The \$600 threshold is determined Postal Service-wide via automated processing, not per paying office. Offices should not be concerned with dollars paid to vendors to determine whether the \$600 threshold share has been met. All 1099 reportable payments regardless of amount are to be recorded on associate office calendar quarter log sheets of 1099 reportable payments. At the end of the calendar year when 1099 processing takes place, data is merged from the on-line 1099 system for associate office payments and APARS. If the total payments are \$600 or greater for a particular Taxpayer ID, a 1099 will be issued.

Revised Form 1096, Receipt (April 1998)

Retail offices must have the revised Form 1096, *Receipt* (April 1998), on hand and available for use no later than **July 15, 1998**. When the revised Form 1096 is received, all Forms 1096 with an edition date other than April 1998 should be destroyed locally.

PS Form 1096 , April 1998		

The revised Form 1096 will be used as a customer receipt for all postal products including the Breast Cancer (BC) Research Stamp. The difference between the prevailing first-class stamp rate and the cost of the BC stamp is a contribution to the BC research fund. All retail channels, including retail windows, contract stations, rural carriers, Contract Express Post Offices, self-service vending, stamps by mail, stamps by fax, mail order/telephone order, and philatelic outlets must have the receipt available when the BC stamp is sold. The BC stamp will not be sold by stamps on consignment.

The normal forms replenishment process should apply in ordering Form 1096, unless other, specific ordering instructions are issued from your district office. The National Stock Number (NSN) for requisitioning Form 1096 is 7530-02-000-7346. The replenishment process will not apply to stamp packets purchased through self-service vending machines. Receipts for purchases through vending machines will be packaged with the stamps in the glassine envelopes.

The stamps will go on sale in July 1998. A specific *Postal Bulletin* article and corresponding communication kits will be issued on the sale of the stamp.

Pictorial Cancellations Announcement 98-13

As a community service, the Postal Service offers pictorial cancellations to commemorate local events celebrated in communities throughout the nation. A list of events for which pictorial cancellations are authorized appears below. If available, the sponsor of the pictorial cancellation appears in italics under the date. Also provided, as space permits, are illustrations of those cancellations that were reproducible and available at press time.


People attending these local events may obtain the cancellation in person at the temporary post office station established there. Those who cannot attend the event, but who wish to obtain the cancellation, may submit a mail order request. Pictorial cancellations are available only for the dates indicated, and *requests must be postmarked no later than 30 days following the requested pictorial cancellation date.*


All requests must include a stamped envelope or postcard bearing at least the minimum First-Class Mail postage (32 cents per envelope or 20 cents per postcard). Items

submitted for cancellation may not include postage issued after the date of the requested cancellation. Such items will be returned unserviced.

Customers wishing to obtain a cancellation should affix stamps to any envelope or postcard of their choice, address the envelope or postcard to themselves or others, insert a card of postcard thickness in envelopes for sturdiness, and tuck in the flap. Place the envelope or postcard in a larger envelope and address it to: PICTORIAL CANCELLATIONS, followed by the NAME OF THE STATION, ADDRESS, CITY, STATE, ZIP + 4 CODE, exactly as listed below (using all capitals and no punctuation, except the hyphen in the ZIP + 4 code).

After applying the pictorial cancellation, the Postal Service returns the envelope or postcard through the mail. Customers who want their serviced item returned under protected cover should include a larger, stamped, self addressed envelope.

SURVEY NOTICE

Voice of the Employee Survey

A sample of career postal employees as well as all career city carriers will be sent a Voice of the Employee (VOE) survey at work. The surveys will be mailed the week of June 29 and surveys need to be completed and returned by July 29. For offices sent 10 surveys or less, surveys will be mailed individually to the person's work location. For offices sent 11 or more surveys, they will be sent to the postmaster or plant manager sorted by pay location.

Send completed survey forms directly to the contractor in the envelopes provided. If an employee is no longer with the Postal Service or is on extended leave, send the survey back to the return address. If an employee has changed job locations, forward the survey to the new location.

Completion of the survey is voluntary and on the clock. The maximum amount of time allotted to complete the survey is 15 minutes. The Management Operating Data System (MODS) offices should track hours spent on the survey using operation number 515 for nonsupervisory employees and operation number 481 for supervisory unit employees. In non-MODS offices, use labor distribution code (LDC) 88 for supervisory hours and LDC 89 for nonsupervisory hours.

Regular rural carriers who elect to complete the survey are compensated for their time at the rural carrier average consolidated work-hour rate. The local office must complete PS Form 8127, *Rural Carrier Supplemental Payment* (July 1994), and send this form to the district office following established procedures for submission of this form for payment. Indicate on PS Form 8127 that payment request is for the Voice of the Employee survey.

EMA ALLOWANCE

Equipment Maintenance Allowance Schedules for Rural Routes

In accordance with the provisions of Article 9, Section 2.1.3 of the Rural Carrier National Agreement, effective July 4, 1998 (Pay Period 15, 1998), the equipment maintenance allowance (EMA) will decrease from \$0.360 cents per mile to \$0.355 cents per mile. The EMA will be \$0.355 cents per mile or a minimum of \$14.20 per day, whichever is greater.

Employees providing auxiliary assistance or serving auxiliary routes (auxiliary rural carriers, rural carrier reliefs, rural carrier associates, and auxiliary assistance under provisions of Article 9, Section 2.1.5) will receive an EMA of \$0.355 cents per mile or \$4.15 per hour, whichever is greater, not to

exceed the amount provided in the special equipment maintenance for the route stops and miles.

The EMA schedule on pages 47 and 48 supersedes all previously published EMA schedules. The optional EMA rate, effective November 8, 1997, remains at \$0.527 cents per mile.

Attention All FIRSTCLASS PHONECARD™ Selling Offices

As first explained in *Postal Bulletin* 21970 (4-23-98), all units must return immediately any remaining FIRSTCLASS PHONECARD inventory with the American Express Telecom, Inc. logo. If sold, these cards cannot be activated on your terminals and the customer will receive a card that is unusable (obsolete).

To return remaining inventory with the American Express Telecom, Inc. (AETI) logo on it, follow the instructions below:

- Remove all FIRSTCLASS PHONECARDS with the AETI logo (blue box) from retail drawers, vending machines, and storage.
- For inventory with the AETI logo on it, separate activated cards (batch or otherwise) from inactive cards. Note that all non-magnetic stripe inventory is active.
- Complete the appropriate Certification of Inventory Return sheets for either Activated or Inactive cards, which are located on pages 51 and 53.

- Send all activated cards with the AETI blue box logo (full batches and loose cards) by Registered Mail to:

AIC 086

Clarification on AIC 086 for Precanceled Stamp Sales

Postal Bulletin 21973 (6-4-98) announced a new Account Identification Code (AIC), AIC 086, which is to be used for all sales of precanceled stamps. The AIC became effective on June 20, 1998, the first day of AP 11. Please note that this AIC should also be used for sales of nonprofit and bulk rate envelopes. Although these products are no longer referred to as "precanceled," they are similar to precanceled stamps in that they are sold and mailed in bulk quantities and require the customer to hold a permit. In summary, AIC 086 applies to the following products:

- Bulk rate precanceled stamps
- First-class presort precanceled stamps
- Nonprofit precanceled stamps
- Nonprofit envelopes
- Bulk rate envelopes

AIC 086 should not be used for sales of large quantities of regular rate stamps or regular rate stamped envelopes.
